PRELIMINARY

1 EXCLUSION OF OTHER REGULATIONS

No regulations or articles set out in any statute, or in any statutory instrument or other subordinate legislation made under any statute, concerning companies shall apply as regulations or articles of the Company.

2 INTERPRETATION

2.1 In these Articles, unless the context otherwise requires:

1985 Act	means the Companies Act 1985;
2006 Act	means the Companies Act 2006;
Acts	means the 1985 Act and the 2006 Act;
address	includes a number or address used for the purposes of sending or receiving notices, documents or information by electronic means;
these Articles	means these articles of association as altered from time to time;
Auditors	means the auditors of the Company;
Board	means the board of directors of the Company or the Directors present or deemed to be present at a duly convened meeting of the Directors at which a quorum is present;
certificated share	means a share that is not an uncertificated share and references in these Articles to a share being in, or being held in, certificated form shall be construed accordingly;
clear days	means, in relation to a period of notice, that period excluding both the day on which the notice is served or deemed to be served and the day on which it is given or on which it is to take effect;
committee	means a committee of the Board;
Companies Acts	means the Acts and every statute (including any statutory instrument or other subordinate legislation made under it) from

	time to time in force concerning companies so far as it applies to the Company;
Company	means Jarvis Securities plc, a public limited company incorporated and registered in England and Wales with registered number 05107012;
Director	means a director of the Company;
dividend	includes bonus and any other distribution whether in cash or in specie;
electronic form	has the meaning given in section 1168 of the Act;
electronic means	has the meaning given in section 1168 of the Act;
general meeting	means any general meeting of the Company including any general meeting held as the Company's annual general meeting in accordance with the provisions of the Companies Acts;
hard copy form	has the meaning given in section 1168 of the Act;
holder	means, in relation to any share, the person whose name is entered in the Register as the holder of that share and includes two or more joint holders of that share;
meeting of the Company	includes both a general meeting and a meeting of the holders of any class of shares;
member	means a member of the Company;
month	means calendar month;
Office	means the registered office of the Company;
Operator	means a person approved by HM Treasury under the uncertificated securities rules as Operator of a Relevant System;
Operator-instruction	means a properly authenticated dematerialised instruction attributable to the Operator;
Operator register of securities	has the meaning given in the uncertificated securities rules;
Ordinary Shares	means the ordinary shares of £0.0025 each in the capital of the Company;
Paid up	means paid up or credited as paid up;
Participating class	means a class of shares title to which is permitted by the Operator to be transferred by means of a Relevant System;
Participating Security	means a security title to units of which the Operator is permitted to transfer by means of a Relevant System;

Person entitled by transmission	means a person whose entitlement to a share in consequence of the death or bankruptcy of a member or of any other event giving rise to its transmission by operation of law has been noted in the Register;
Register	means the register of members of the Company;
Regulations	means the Uncertificated Securities Regulations 2001 (SI 2001/3755);
Relevant System	means a computer-based system and procedures, permitted by the uncertificated securities rules, which enable title to units of a security to be evidenced and transferred without a written instrument and which facilitate supplementary and incidental matters;
Seal	means any common seal or official seal that the Company may have as permitted under the Companies Acts;
Securities Seal	means an official seal which is a facsimile of the Seal with the addition on its face of the word Securities;
Secretary	means the secretary of the Company and includes a joint, assistant or deputy secretary and any other person appointed by the Board to perform any of the duties of the secretary;
share	means a share in the capital of the Company;
Statutes	means the Companies Acts, the Regulations and every other statute and statutory instrument for the time being in force concerning companies and affecting the Company;
Transfer Office	means the place where the Register is situated;
Treasury Shares	has the meaning given in the 2006 Act;
Uncertificated Proxy Instruction	means a properly authenticated dematerialised instruction and/or other instruction or notification, which is sent by means of a Relevant System and received by such participant in that system acting on behalf of the Company as the Board may prescribe, in such form and subject to such terms and conditions as may from time to time be prescribed by the Board (subject always to the facilities and requirements of the Relevant System concerned);
uncertificated securities rules	means any provision of the Companies Acts relating to the holding, evidencing of title to, or transfer of uncertificated shares and any legislation, rules or other arrangements made under or by virtue of such provision;
uncertificated share	means a share which is recorded on the Register as being held in uncertificated form and title to which may, by virtue of the uncertificated securities rules, be transferred by means of a Relevant System and references in these Articles to a share

being in, or being held in, uncertificated form shall be construed accordingly;

United Kingdom means Great Britain and Northern Ireland;

working day has the meaning given in section 1173 of the Act; and **year** means calendar year.

2.2 In these Articles, unless the context otherwise requires:

2.2.1 words in the singular include the plural and vice versa;

2.2.2 words which refer to one gender include all genders;

2.2.3 references to a **person** include references to a body corporate and to an unincorporated body of persons (whether or not having separate legal personality);

2.2.4 references to a **meeting** shall not be taken as requiring more than one person to be present if any quorum requirement can be satisfied by one person;

2.2.5 references to a document being **executed** or **signed** include references to its being executed or signed under hand or under seal or by any other method and, in the case of a document in electronic form, such references are to its being authenticated as specified in section 1146 of the Act;

2.2.6 references to **writing** include references to any method or combination of methods of representing or reproducing words, symbols or other information in a legible and non-transitory form (including in electronic form) and **written** shall be construed accordingly; and

2.2.7 references to an Article by number are to the relevant numbered paragraph of these Articles.

2.3 Unless the context otherwise requires, any word or expression contained in these Articles which is not defined in this Article 2 but which is defined in the Companies Acts shall have the same meaning as in the Companies Acts but excluding any statutory modification of that meaning made after the date of adoption of these Articles.

2.4 References in these Articles to any statute or any provision of any statute shall, unless the context otherwise requires, include any modification or re-enactment of that statute or provision from time to time in force.

2.5 A special resolution shall be effective for any purpose for which an ordinary resolution is expressed to be required under any provision of these Articles.

2.6 The headings in these Articles are included for convenience only and do not affect the meaning of these Articles.

3 **LIMITED LIABILITY**

The liability of the members of the Company is limited to the amount, if any, unpaid on the shares in the Company held by them.

4 UNRESTRICTED OBJECTS

Nothing in these Articles shall constitute a restriction on the objects of the Company and, in accordance with section 31(1) of the Act, the Company's objects are unrestricted.

5 CHANGE OF NAME

The Company may change its name by resolution of the Board.

6 SITUATION OF REGISTERED OFFICE

The Company's registered office is to be situated in England and Wales.

SHARE CAPITAL

7 POWER TO ATTACH RIGHTS

Subject to the provisions of the Companies Acts and to any rights attached to any existing shares, any share may be issued with or have attached to it such rights or restrictions as the Company may by ordinary resolution determine or, in the absence of any such determination, as the Board may decide. Such rights and restrictions shall apply to the relevant shares as if they were set out in these Articles.

8 REDEEMABLE SHARES

Subject to the Companies Acts and to any rights attaching to existing shares, any share may be issued which can be redeemed or is liable to be redeemed at the option of the Company or the holder. The Board may determine the terms, conditions and manner of redemption of any redeemable shares which are issued. Such terms and conditions shall apply to the relevant shares as if the same were set out in these Articles.

9 ALLOTMENT

9.1 Subject to the provisions of the Companies Acts and these Articles and to any resolution of the Company and without prejudice to any rights attached to any existing shares, the Board may offer, allot (with or without conferring a right of renunciation), grant options over or otherwise deal with or dispose of any shares to such persons, at such times, for such consideration and upon such terms as the Board may decide provided always that no share shall be issued at a discount to its nominal value.

9.2 No share in the Company may be issued at a discount to its nominal value.

10 RENUNCIATION OF ALLOTMENT

The Board may, at any time after the allotment of any share but before any person has been entered in the Register as the holder, recognise a renunciation of that allotment by the allottee in favour of some other person and may accord to any allottee of a share a right to effect such renunciation and or allow the rights represented thereby to be one or more participating securities, in each case upon and subject to such terms and conditions as the Board may think fit to impose.

11 POWER TO PAY COMMISSION AND BROKERAGE

11.1 The Company may in connection with the issue of any shares or the sale for cash of Treasury Shares exercise all powers of paying commission and brokerage conferred or permitted by the Companies Acts.

- 11.2 Subject to the provisions of the Companies Acts, any such commission or brokerage may be satisfied by:
- 11.2.1 the payment of cash; or
 - 11.2.2 the allotment of fully or partly paid shares or other securities; or
 - 11.2.3 the grant of an option to call for an allotment of shares or other securities; or
 - 11.2.4 any combination of such methods.

12 TRUSTS NOT RECOGNISED

Except as ordered by a court of competent jurisdiction or as required by law:

- 12.1.1 no person shall be recognised by the Company as holding any share on any trust; and
- 12.1.2 the Company shall not be bound by or required in any way to recognise (even if it has notice of it) any equitable, contingent, future, partial or other claim to or interest in any share other than an absolute right in the holder to the whole of the share.

VARIATION OF RIGHTS

13 MANNER OF VARIATION OF RIGHTS

- 13.1 Subject to the provisions of the Companies Acts, if at any time the share capital of the Company is divided into shares of different classes, all or any of the rights attached to any class may be varied, either while the Company is a going concern or during or in contemplation of a winding up:
- 13.1.1 with the consent in writing of the holders of not less than three-fourths in nominal value of the issued shares of that class (excluding any shares of that class held as Treasury Shares); or
 - 13.1.2 with the sanction of a special resolution passed at a separate meeting of the holders of the issued shares of that class duly convened and validly held in accordance with the provisions of these Articles.
- 13.2 The rights attached to any class of shares shall not, unless otherwise expressly provided in the rights attaching to those shares, be deemed to be varied by:
- 13.2.1 the creation or issue of further shares ranking pari passu with or subsequent to them; or
 - 13.2.2 the purchase or redemption by the Company of any of its own shares.

14 CLASS MEETINGS

- 14.1 All the provisions of these Articles relating to general meetings shall, with any necessary modifications, apply to every separate meeting of the holders of any class of shares except that:
- 14.1.1 no member, other than a Director, shall be entitled to notice of, or to attend, any such meeting unless he is a holder of shares of the relevant class;

- 14.1.2 the quorum at any such meeting (other than an adjourned meeting) shall be not less than two persons entitled to vote and holding or representing by proxy at least one third in nominal value of the issued shares of the relevant class (excluding any shares of that class held as treasury shares);
 - 14.1.3 the quorum at any adjourned meeting shall be one person holding shares of the relevant class who is present in person or by proxy and entitled to vote (whatever the number of shares held by him);
 - 14.1.4 any holder of shares of the relevant class who is present in person or by proxy and entitled to vote may demand a poll; and
 - 14.1.5 on a poll, each such holder shall have one vote for every share of the relevant class held by him.
- 14.2 The Board may convene a meeting of the holders of any class of shares whenever it thinks fit and whether or not the business to be transacted involves a variation of class rights.

15 **SUB-DIVISION**

Any resolution authorising the Company to sub-divide its shares or any of them may determine that, as between the shares resulting from the sub-division, any of them may have any preference or advantage or be subject to any restriction as compared with the others.

16 **FRACTIONS**

- 16.1 Subject to any direction by ordinary resolution of the Company, whenever as the result of a consolidation or sub-division of shares, any members would become entitled to fractions of a share, the Board may:

16.1.1 deal with the fractions as it thinks fit and, in particular, may arrange for the sale of the shares representing the fractions to which any members would otherwise become entitled to any person (including, subject to the Companies Acts, the Company) and distribute the net proceeds of sale in due proportion among those members except that any amount otherwise due to a member of less than £5 (or such other sum as the Board may from time to time decide) may be retained for the benefit of the Company or distributed to an organisation which is a charity for the purposes of the law of England and Wales, Scotland or Northern Ireland. For the purpose of any such sale, the Board may:

16.1.1.1 if the shares to be sold are in certificated form, authorise any person to sign an instrument of transfer of the shares; or

16.1.1.2 if the shares to be sold are in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the shares,

in either case, in accordance with the directions of the purchaser and may cause the name of the transferee to be entered in the Register as the holder of the shares which have been sold. The transferee shall not be bound to see to the application of the purchase moneys nor shall his title to the shares be affected by any irregularity in, or invalidity of, the proceedings relating to the sale; or

16.1.2 subject to the provisions of the Companies Acts, issue to each such member credited as fully paid up by way of capitalisation the minimum number of shares required to round up his holding to an exact multiple of the number of shares to

be consolidated into a single share (such issue being deemed to have been effected immediately before consolidation). The amount required to pay up such shares shall be appropriated, at the Board's discretion, from any sums standing to the credit of any of the Company's reserve accounts (including share premium account and capital redemption reserve) or to the credit of the profit and loss account or retained earnings and capitalised by applying the same in paying up such shares. In relation to the capitalisation, the Board may exercise all the powers conferred on it by Article 141 without an ordinary resolution of the Company.

UNCERTIFICATED SHARES

17 SHARES IN UNCERTIFICATED FORM

17.1 In accordance with and subject to the uncertificated securities rules, the Board may permit title to shares of any class to be evidenced otherwise than by a certificate and title to shares of such a class to be transferred by means of a Relevant System and may make arrangements for a class of shares (if all shares of that class are identical) to become a participating class. Title to shares of a particular class may only be evidenced otherwise than by a certificate where that class of shares is at the relevant time a participating class. The Board may also, subject to compliance with the uncertificated securities rules, decide at any time that title to any class of shares may from a date specified by the Board no longer be evidenced otherwise than by a certificate or that title to shares of such a class shall cease to be transferred by means of a Relevant System.

17.2 In relation to a class of shares which is a participating class and for so long as it remains a participating class, no provision of these Articles shall apply or have effect to the extent that it is in any respect inconsistent with:

17.2.1 the holding of shares of that class in uncertificated form; or

17.2.2 the transfer of title to shares of that class by means of a Relevant System; or

17.2.3 any provision of the uncertificated securities rules,

and, without prejudice to the generality of this Article, no provision of these Articles shall apply or have effect to the extent that it is in any respect inconsistent with the maintenance, keeping or entering up by the Operator, so long as that is permitted or required by the uncertificated securities rules, of an Operator register of securities in respect of that class of shares in uncertificated form.

17.3 In accordance with and subject to the uncertificated securities rules, shares of a class which is at the relevant time a participating class may be changed from uncertificated to certificated form and from certificated to uncertificated form.

17.4 If, under any provision of these Articles or the Companies Acts, the Company is entitled to sell, transfer or otherwise dispose of, forfeit, re-allot, accept the surrender of or otherwise enforce a lien over a share held in uncertificated form, then, subject to the provisions of these Articles and the Companies Acts, such entitlement shall include the right of the Board:

17.4.1 to require the holder of that uncertificated share by notice to change that share into certificated form within the period specified in the notice and to hold that share in certificated form for so long as required by the Company;

- 17.4.2 to require the holder of that uncertificated share by notice to give any instructions necessary to transfer title to that share by means of a Relevant System within the period specified in the notice;
 - 17.4.3 to appoint any person to take such other steps (including without limitation the giving of any instructions by means of a Relevant System) in the name of the holder of such share as may be required to effect the transfer of title to that share and such steps shall be as effective as if they had been taken by the registered holder of that share; and
 - 17.4.4 to take such other action that the Board considers appropriate to achieve the sale, transfer, disposal, forfeiture, re-allotment or surrender of that share or otherwise to enforce a lien over that share.
- 17.5 Unless the Board otherwise decides, shares held by a member in uncertificated form will be treated as a separate holding from any shares held by that member in certificated form. However, shares held in uncertificated form shall not be treated as forming a class which is separate from certificated shares with the same rights.
- 17.6 Unless the Board otherwise decides or the uncertificated securities rules otherwise require:
- 17.6.1 any shares issued or created out of or in respect of any uncertificated shares shall be uncertificated shares; and
 - 17.6.2 any shares issued or created out of or in respect of any certificated shares shall be certificated shares.
- 17.7 The Company shall be entitled to assume that the entries on any record of securities maintained by it in accordance with the uncertificated securities rules and regularly reconciled with the relevant Operator register of securities are a complete and accurate reproduction of the particulars entered in the Operator register of securities and shall accordingly not be liable in respect of any act or thing done or omitted to be done by or on behalf of the Company in reliance on such assumption. In particular, any provision of these Articles which requires or envisages that action will be taken in reliance on information contained in the Register shall be construed to permit that action to be taken in reliance on information contained in any relevant record of securities (as so maintained and reconciled).

SHARE CERTIFICATES

18 ISSUE OF SHARE CERTIFICATES

- 18.1 The Company shall issue a share certificate to every person whose name is entered in the Register in respect of shares in certificated form (except a person to whom the Company is not by law required to issue a certificate). Each share certificate must be in respect of one class of shares only. If a member holds more than one class of shares, separate certificates must be issued to that member in respect of each class of shares held by him.
- 19 The Company shall not be bound to register more than four persons as the joint holders of a share and in the case of a share held jointly by several persons the Company shall not be bound to issue more than one certificate therefor and delivery of a certificate to any one of such persons shall be sufficient delivery to all.
- 19.1 A member who transfers some only of the shares represented by a share certificate shall be entitled to a new certificate for the balance to the extent that the balance is to be held in certificated form.

- 19.2 The Company shall issue share certificates within the time limits prescribed by the Companies Acts (or, if earlier, within any time limit specified in the terms of the shares or under which they were issued).
- 19.3 Subject to Article 23, the Company shall issue share certificates free of charge.
- 19.4 Every share certificate sent in accordance with these Articles will be sent at the risk of the member or other person entitled to the certificate. The Company will not be responsible for any share certificate lost or delayed in the course of delivery.

20 **FORM OF SHARE CERTIFICATE**

- 20.1 Every share certificate shall specify the number and class of shares to which it relates, the nominal value of those shares, the amount paid up on them and the distinguishing numbers (if any) assigned to them.
- 21 Every share certificate shall be issued under the Seal (or under a Securities Seal or, in the case of shares on a branch register, under an official seal for use in the relevant territory) or in such other manner as the Board may approve or as may be permitted by the Companies Acts. Whether or not share certificates are issued under the Seal, the Board may decide, either generally or in any particular case or cases, that any signatures on share certificates need not be autographic but may be applied by some mechanical, electronic or other means or may be printed on them or that the certificates need not be signed by any person.
- 22 No certificate need be issued in respect of shares held by a recognised clearing house (within the meaning of the Financial Services and Markets Act 2000) or a nominee of a recognised clearing house or of a recognised investment exchange (within the meaning of the Financial Services and Markets Act 2000)

23 **REPLACEMENT SHARE CERTIFICATES**

- 23.1 Subject to Article 23.2:
- 23.1.1 a member who has two or more share certificates representing shares of any one class may request in writing that such certificates be cancelled and replaced with a single new certificate for such shares and the Company may comply with such request at its discretion;
- 23.1.2 a member who has a share certificate representing shares of any one class may request in writing that such certificate be cancelled and replaced with two or more new certificates representing such shares in such proportions as he may specify and the Company may comply with such request at its discretion; and
- 23.1.3 if a share certificate issued to a member is damaged, defaced, worn out or said to be lost, stolen or destroyed, the member may request in writing that a new certificate representing the same shares be issued to him and the Company shall comply with such request.
- 23.2 No new certificate will be issued pursuant to Article 23.1 unless the relevant member:
- 23.2.1 has first delivered the old certificate or certificates to the Company for cancellation (except for any certificate which is said to be lost, stolen or destroyed);
- 23.2.2 has complied with such conditions as to evidence and indemnity (with or without security) as the Board may think fit; and

23.2.3 has paid to the Company such reasonable fee as the Board may decide.

23.3 In the case of shares held jointly by more than one person, any such request as is mentioned in Article 23.1 may be made by any one of the joint holders.

LIEN ON SHARES

24 COMPANY'S LIEN ON SHARES NOT FULLY PAID

The Company shall have a first and paramount lien on every share which is not fully paid for all amounts payable (whether presently or not) in respect of that share. The Company's lien on a share shall extend to all amounts (including without limitation dividends) payable in respect of it. The Board may at any time, either generally or in any particular case, waive any lien that has arisen or declare any share to be wholly or partly exempt from the provisions of this Article.

25 SALE OF SHARES SUBJECT TO LIEN

25.1 The Company may sell, in such manner as the Board may decide, any share on which the Company has a lien if:

25.1.1 a sum in respect of which the lien exists is presently payable; and

25.1.2 such sum is not paid within 14 clear days after a notice has been served on the holder of the share (or any person entitled to the share by transmission) demanding payment and stating that if the notice is not complied with the share may be sold.

25.2 To give effect to any such sale, the Board may:

25.2.1 if the share is held in certificated form, authorise any person to sign as transferor an instrument of transfer of the share; or

25.2.2 if the share is held in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the share (including the exercise of any of the Company's powers under Article 17.4),

in either case, to or in accordance with the directions of the purchaser and may cause the name of the transferee to be entered in the Register as the holder of the share which has been sold. The transferee shall not be bound to see to the application of the purchase moneys nor shall his title to the share be affected by any irregularity in, or invalidity of, the proceedings relating to the sale.

26 APPLICATION OF PROCEEDS OF SALE

26.1 The net proceeds of the sale by the Company of any share on which it has a lien shall, after payment of the costs of sale, be applied by the Company in or towards payment or satisfaction of the amount in respect of which the lien exists so far as the same is presently payable. Any residue shall (subject to a like lien for any amounts not presently payable as existed on the share before the sale) be paid to the person entitled to the share immediately before the sale (without interest) provided that, in the case of certificated shares, the Company shall not be obliged to make any such payment until the certificate representing the share sold has been surrendered to the Company for cancellation (or, if the certificate is alleged to have been lost, stolen or destroyed, until an indemnity (with or without security) has been provided to the Company in such form as the Board may require). For giving effect

to any such sale the Board may authorise some person to transfer the shares sold to the purchaser.

- 26.2 A statutory declaration by a Director or the Secretary that a share has been duly forfeited or surrendered or sold to satisfy a lien of the Company on a date stated in the declaration shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share. Such declaration and the receipt of the Company for the consideration (if any) given for the share on the sale, re-allotment or disposal thereof together with the share certificate (in the case of shares in certificated form) delivered to a purchaser or allottee thereof shall (subject to the execution of a transfer if the same be required) constitute a good title to the share and the person to whom the share is sold, re-allotted or disposed of shall be registered as the holder of the share and shall not be bound to see to the application of the purchase money (if any) nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, surrender, sale, re-allotment or disposal of the share.

CALLS ON SHARES

27 CALLS

- 27.1 Subject to the provisions of these Articles and the terms on which shares are allotted, the Board may from time to time make calls on the members in respect of any moneys unpaid on their shares (whether in respect of nominal value or any premium) and not payable on a date fixed by or in accordance with the terms of allotment.
- 27.2 Each member shall (subject to the Company serving on him at least 14 clear days' notice specifying when and where payment is to be made) pay to or as directed by the Company as required by the notice the amount called on his shares.
- 27.3 A call may be required to be paid by instalments.
- 27.4 At any time before receipt by the Company of any sum due under a call, the call may be wholly or in part revoked or the time for payment postponed as the Board may decide.
- 28 A person on whom a call is made shall remain liable jointly and severally with the successors in title to his shares for all calls made on him even though the shares in respect of which the call was made are subsequently transferred.

29 TIMING OF CALLS

A call shall be deemed to have been made at the time when the resolution of the Board authorising the call was passed or, where the power to make calls has been delegated pursuant to these Articles, at the time when the person to whom the power has been delegated serves notice of exercise of such power.

30 LIABILITY OF JOINT HOLDERS

The joint holders of a share shall be jointly and severally liable for payment of all calls in respect of such share.

31 INTEREST ON OVERDUE AMOUNTS

If a call remains unpaid after it has become due and payable, the person from whom it is due and payable shall pay all expenses that have been incurred by the Company by reason of such non-payment together with interest on the amount unpaid from the day it is due and

payable to the time of actual payment at such rate (not exceeding the Bank of England base rate by more than five percentage points) as the Board may decide. The Board may waive payment of the interest or the expenses in whole or in part.

32 DEEMED CALLS

An amount payable in respect of a share on allotment or on any other date fixed by or in accordance with the terms of allotment, whether in respect of nominal value or premium or as an instalment of a call, shall be deemed to be a call duly made and notified and payable on the date fixed for payment. In the case of non-payment of any such amount, all the provisions of these Articles shall apply as if such sum had become due and payable by virtue of a call.

33 POWER TO DIFFERENTIATE BETWEEN HOLDERS

The Board may, on or before the allotment of shares, make different arrangements, as between the allottees or holders of such shares, in the amount and time of payment of calls.

34 PAYMENT IN ADVANCE OF CALLS

34.1 The Board may, if it thinks fit, receive from any member willing to advance the same all or any part of the moneys uncalled and unpaid on any share held by him. Such payment in advance of calls shall extinguish the liability on the share in respect of which it is made to the extent of the amount so paid.

34.2 The Company may pay on all or any of the moneys so advanced (until they would but for such advance become payable) interest at such rate (not exceeding, without the sanction of the Company given by ordinary resolution, 15 per cent per annum) as the Board may decide.

34.3 No moneys paid in advance of calls shall be taken into account in ascertaining the amount of any dividend payable on any share in respect of which such advance has been made.

FORFEITURE

35 NOTICE ON FAILURE TO PAY A CALL

If a call or an instalment of a call remains unpaid in whole or in part after it has become due and payable, the Board may at any time give notice to the person from whom it is due demanding payment of the amount unpaid together with any interest which may have accrued on that amount and any costs, charges and expenses incurred by the Company by reason of such non-payment. The notice shall state:

35.1.1 a date (being not less than 7 clear days from the date of service of the notice) on or before which payment of the amount demanded by the notice is to be made;

35.1.2 the place where payment is to be made; and

35.1.3 that, if the notice is not complied with, the shares in respect of which the call was made will be liable to be forfeited.

36 FORFEITURE FOR NON-COMPLIANCE

If the notice referred to in Article 35 is not complied with, any share in respect of which the notice was given may, at any time before the payment required by the notice has been made, be forfeited by a resolution of the Board to that effect and the forfeiture shall be deemed to occur at the time of the passing of such resolution. The forfeiture shall include all dividends

declared and other moneys payable in respect of the forfeited share which have not been paid before the forfeiture.

37 NOTICE AFTER FORFEITURE

When a share has been forfeited, notice of the forfeiture shall be served on the person who was, before the forfeiture, the holder of the share (or the person, if any, entitled to the share by transmission). An entry that notice of the forfeiture has been given and that the share has been forfeited, with the relevant date, shall be made in the Register opposite the entry in respect of the share. No forfeiture shall be invalidated by any omission or neglect to send such notice or make such entry as aforesaid.

38 DISPOSAL OF FORFEITED SHARE

38.1 Until cancelled in accordance with the provisions of the Companies Acts, a forfeited share, together with all rights attaching to it, shall be deemed to be the property of the Company and may be sold, re-allotted or otherwise disposed of on such terms and in such manner as the Board shall decide, either to the person who was, before the forfeiture, the holder thereof (or the person, if any, entitled by transmission to the share) or to any other person and whether with or without all or any part of the amount previously paid up on the share being credited as so paid up. Any share not disposed of in accordance with this Article within a period of three years from the date of its forfeiture or surrender shall, at the expiry of that period, be cancelled in accordance with the Companies Acts.

38.2 The Board may, at any time before any forfeited share has been cancelled, sold, re-allotted or otherwise disposed of, annul the forfeiture on such terms as the Board thinks fit.

38.3 Where for the purposes of its disposal a forfeited share is to be transferred to any person, the Board may:

38.3.1 if the share is held in certificated form, authorise any person to sign as transferor an instrument of transfer of the share; or

38.3.2 if the share is held in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the share (including the exercise of any of the Company's powers under Article 17.4).

38.4 The Company may receive the subscription or purchase moneys (if any) given for a forfeited share on its sale, re-allotment or disposal and may register the allottee or (as the case may be) the transferee as the holder of the share.

39 EFFECT OF FORFEITURE

A shareholder whose shares have been forfeited shall cease to be a member in respect of such forfeited shares and shall surrender the certificate for such shares to the Company for cancellation. Such shareholder shall remain liable to pay to the Company all sums which at the date of forfeiture were presently payable by him or her to the Company in respect of such shares with interest (not exceeding the Bank of England base rate by five percentage points) from the date of the forfeiture to the date of payment. The Directors may waive payment of interest wholly or in part and may enforce payment, without any reduction or allowance for the value of the shares at the time of forfeiture or for any consideration received on their disposal.

40 **EXTINCTION OF CLAIMS**

The forfeiture of a share shall involve the extinction at the time of forfeiture of all interest in and all claims and demands against the Company in respect of the share and all other rights and liabilities incidental to the share as between the person whose share is forfeited and the Company, except only those rights and liabilities which are expressly saved by these Articles or which are given or imposed in the case of past members by the Companies Acts.

41 **EVIDENCE OF FORFEITURE**

A statutory declaration by a Director or the Secretary that a share has been duly forfeited on a specified date shall be conclusive evidence of the facts stated in it as against all persons claiming to be entitled to the share. The declaration shall (subject, if necessary, to the signing of an instrument of transfer) constitute a good title to the share. The person to whom the share is sold, re-allotted or disposed of shall not be bound to see to the application of the subscription or purchase moneys (if any) nor shall his title to the share be affected by any irregularity in, or invalidity of, the proceedings relating to the forfeiture, sale, re-allotment or disposal of the share.

42 **SURRENDER**

The Board may accept the surrender of any share liable to be forfeited on and subject to such terms and conditions as the Board may decide. Subject to those terms and conditions, a surrendered share shall be treated as if it had been forfeited and the provisions of these Articles applicable to a forfeited share shall also apply to a surrendered share and, in such a case, references in these Articles to forfeiture shall include surrender.

TRANSFER OF SHARES

43 **FORM OF TRANSFER**

43.1 Subject to the provisions of these Articles:

43.1.1 any member may transfer all or any of his shares which are in certificated form by a written instrument of transfer in any usual or common form or in any other form approved by the Board ; and

43.1.2 any member may transfer all or any of his shares which are in uncertificated form by means of a Relevant System in such manner as is provided for under, and subject as provided in, the uncertificated securities rules and, accordingly, no provision of these Articles shall apply in respect of an uncertificated share to the extent that it requires or contemplates the effecting of a transfer by an instrument in writing or the production of a share certificate.

43.2 The transferor shall be deemed to remain the holder of any share transferred until the name of the transferee is entered in the Register in respect of it.

43.3 The instrument of transfer of a share shall be signed by or on behalf of the transferor and (in the case of the transfer of a share which is not fully paid) by or on behalf of the transferee.

43.4 All instruments of transfer which are registered may be retained by the Company.

44 **NO FEE ON REGISTRATION**

No fee shall be charged by the Company for the registration of a transfer of a share or any other document relating to or affecting the title to any share or the right to transfer it or for making any other entry in the Register.

45 **BOARD'S POWER TO REFUSE REGISTRATION**

45.1 The Board may, in its absolute discretion and without assigning any reason therefor, refuse to register the transfer of a share which is not fully paid or on which the Company has a lien provided that, in the case of a class of shares which has been admitted to the AIM market operated by London Stock Exchange plc, such discretion may not be exercised in such a way as to prevent dealings in the shares of that class from taking place on an open and proper basis.

45.2 The Board may, in its absolute discretion and without assigning any reason therefor, refuse to register the transfer of a certificated share unless:

45.2.1 the instrument of transfer is in respect of only one class of share;

45.2.2 the instrument of transfer is in favour of not more than four persons jointly; and

45.2.3 the instrument of transfer:

45.2.3.1 is duly stamped (or is duly certified or otherwise shown to the satisfaction of the Board to be exempt from stamp duty);

45.2.3.2 is lodged at the Transfer Office (or such other place as the Board may appoint); and

45.2.3.3 (except in the case of a transfer by a person to whom the Company is not by law required to issue a certificate and to whom a certificate has not been issued) is in respect of one class of shares, duly stamped, accompanied by the certificate(s) for the share to which it relates and such other evidence as the Board may reasonably require to show the right of the transferor to make the transfer (and, if the instrument of transfer is signed by some other person on his behalf, the authority of that person to do so).

45.3 The Board may, in its absolute discretion and without assigning any reason therefor, refuse to register the transfer of an uncertificated share:

45.3.1 in the circumstances set out in the uncertificated securities rules; and

45.3.2 where, in the case of a transfer to joint holders, the number of joint holders to whom the share is to be transferred exceeds four.

45.4 If the Board refuses to register a transfer of a share, the Board shall, within two months after the date on which the instrument of transfer was lodged (in the case of certificated shares) or the Operator-instruction was received by the Company (in the case of uncertificated shares), send to the transferee notice of the refusal setting out the reasons for the refusal together with (in the case of shares held in certificated form) the instrument of transfer.

45.5 Subject to Article 45.6, all instruments of transfer which are registered may be retained by the Company and subject to the Regulations, the Company shall be entitled to destroy:

- 45.5.1 all instruments of transfer which have been registered at any time after the expiration of six years from the date of registration thereof;
- 45.5.2 all dividend mandates and notifications of change of address at any time after the expiration of two years from the date of recording thereof;
- 45.5.3 all share certificates which have been cancelled at any time after the expiration of one year from the date of cancellation thereof;
- 45.5.4 all appointments of proxy which have been used for the purposes of a poll, at any time after the expiration of one year from the date of such use, and all appointments of proxy which have not been used for the purposes of a poll, at any time after one month from the end of the meeting to which the appointments of proxy relates and at which no poll was demanded; and
- 45.5.5 any other document on the basis of which any entry in the Register is made at any time after the expiry of six years from the date an entry in the Register was first made in respect of it, and it shall conclusively be presumed in favour of the Company that every entry in the Register purporting to have been made on the basis of an instrument of transfer or other document so destroyed was duly and properly made and every instrument of transfer so destroyed was a valid and effective instrument duly and properly registered and every share certificate so destroyed was a valid and effective certificate duly and properly cancelled and every other document hereinbefore mentioned so destroyed was a valid and effective document in accordance with the recorded particulars thereof in the books or records of the Company.
- 45.6 Article 45.5 applies only to the destruction of a document in good faith and without notice of any claim (regardless of the parties thereto) to which the document might be relevant and nothing in Article 45.5 shall be construed as imposing upon the Company any liability in respect of the destruction of any such document earlier than as aforesaid or in any other circumstances which would not attach to the Company in the absence of Article 45.5.
- 45.7 References in Articles 45.5 and 45.6 to the destruction of any document include references to the disposal thereof in any manner.
- 45.8 No fee will be charged by the Company in respect of the registration of any instrument of transfer, probate, letters of administration, certificate of marriage or death, stop notice, power of attorney or other document relating to or affecting the title to any shares or otherwise for making any entry in the Register affecting the title to any shares.
- 45.9 Subject to the Statutes, the Company, or the Board on behalf of the Company, may cause to be kept in any territory a branch register of members resident in such territory, and the Board may make and vary such regulations as they may think fit regarding the keeping of any such register.
- 45.10 Subject to the Statutes, the Board may determine that any class of shares may be held in uncertificated form and that title to such shares may be transferred by means of a Relevant System or that shares of any class should cease to be held and transferred as aforesaid.

46 RENUNCIATION

- 46.1 For all purposes of these Articles relating to the registration of transfers of shares, a renunciation of the allotment of any shares by the allottee in favour of some other person

shall be deemed to be a transfer and the Board shall have the same powers of refusing to give effect to such a renunciation as if it were a transfer.

UNCERTIFICATED HOLDINGS

- 46.2 Subject to the Statutes the Board may resolve that a class of shares is to become a participating security and may at any time determine that a class of shares shall cease to be a Participating Security.
- 46.3 The provisions of these Articles shall not apply to shares of any class which are in uncertificated form to the extent that such Articles are inconsistent with:
- 46.3.1 the holding of shares of that class in uncertificated form;
 - 46.3.2 the transfer of title to shares of that class by means of a Relevant System; or
 - 46.3.3 any provision of the Regulations.
- 46.4 Any share of a class which is a participating security may be changed from an uncertificated share to a certificated share and from a certificated share to an uncertificated share in accordance with the Regulations.
- 46.5 For the purpose of effecting any actions by the Company, the Board may determine that holdings of the same member in uncertificated form and in certificated form shall be treated as separate holdings.
- 46.6 In relation to shares which are in uncertificated form, any provisions of these Articles enabling a person to be appointed to execute an instrument of transfer shall have effect of enabling that person to be appointed to authorise the giving of a relevant properly authenticated dematerialised instruction (not being inconsistent with the provisions in question) as may be required for the disposal of the share in question in accordance with the terms of his appointment.
- 46.7 Where the Company is entitled under the Statutes, the Regulations and the rules, procedures or practices of any Relevant System or under these Articles to dispose of, forfeit, accept the surrender of, enforce a lien over, re-allot or sell, transfer or otherwise procure the sale of any shares which are held in uncertificated form, the Board shall have the power (subject to the Statutes, the Regulations and the rules, procedures or practices of the Relevant System) to take such steps as the Board considers appropriate, by instruction by means of a Relevant System or otherwise, to effect such disposal, forfeiture, surrender, enforcement, re-allotment sale or transfer and such powers shall (subject as aforesaid) include the right to:
- 46.7.1 request or require the deletion of any computer based entries in the Relevant System relating to the holding of such shares in uncertificated form; and/or
 - 46.7.2 alter such computer based entries so as to divest the registered holder of such shares of the power to transfer such shares to a person other than the transferee, purchaser or his nominee identified by the Company for this purpose; and/or
 - 46.7.3 require any holder of any uncertificated shares which are the subject of any exercise by the Company of any such entitlement, by notice to the holder concerned, to convert his holding of such uncertificated shares into certificated form within such period as may be specified in the notice prior to completion of any disposal, sale or transfer of such shares or direct the holder to take such steps as may be necessary to sell or transfer such shares; and/or

- 46.7.4 otherwise rectify or change the Register in respect of any such shares in such manner as the Board considers appropriate (including, without limitation, by entering the name of the transferee into the Register as the next holder of such shares); and/or
- 46.7.5 appoint any person to take such steps in the name of the holder of such shares as may be required to effect the conversion and/or transfer of such shares and such steps shall be effective as if they had been taken by the registered holder of the uncertificated shares concerned.
- 46.8 The Company shall not issue to any person a certificate in respect of an uncertificated share.

TRANSMISSION OF SHARES

47 TRANSMISSION ON DEATH

- 47.1 If a member dies, the survivors or survivor (where he was a joint holder) and his personal representatives (where he was a sole or only surviving holder) shall be the only persons recognised by the Company as having any title to his interest in any share held by him.
- 47.2 Nothing in these Articles shall release the estate of a deceased member (whether sole or joint) from any liability in respect of any share held by him.

48 ENTRY OF TRANSMISSION IN THE REGISTER

Where the entitlement of a person to a share in consequence of the death or bankruptcy of a member or of any other event giving rise to its transmission by operation of law is proved to the satisfaction of the Board, the Board shall within two months after proof cause the entitlement of that person to be noted in the Register.

49 ELECTION BY PERSONS ENTITLED BY TRANSMISSION

Any person becoming entitled to a share in consequence of the death or bankruptcy of a member or of any other event giving rise to its transmission by operation of law may, on producing to the Company such evidence as to his entitlement as the Board may properly require, elect either to be registered himself as the holder of the share or to have another person nominated by him registered as the holder of the share. If he elects to be registered himself, he must give notice to the Company to that effect. If he elects to have another person registered and the share is in certificated form, he must execute an instrument of transfer of the share to that person. If he elects to have himself or another person registered and the share is in uncertificated form, he must take such action as the Board may require (including the signing of any document and the giving of any instruction by means of a Relevant System) to enable himself or that person to be registered as the holder of the share. All the provisions of these Articles relating to the transfer of shares shall apply to the notice or transfer as if the event giving rise to the transmission had not occurred and the notice or transfer were a transfer executed by the person from whom the entitlement by transmission is derived.

50 RIGHTS OF PERSONS ENTITLED BY TRANSMISSION

- 50.1 Except as otherwise provided by these Articles, a person becoming entitled to a share in consequence of the death or bankruptcy of a member or of any other event giving rise to its transmission by operation of law is, on producing to the Company such evidence as to his entitlement as the Board may properly require, entitled to:

- 50.1.1 the same dividends and other moneys payable in respect of the share to which he would be entitled if he were the registered holder of the share and may give a good discharge for those dividends or other moneys; and
 - 50.1.2 all other advantages to which he would be entitled if he were the registered holder of the share but he shall not be entitled in respect of the share to receive notice of, or to attend or vote at, meetings of the Company or to exercise any other right conferred by membership in relation to meetings of the Company unless and until he shall have been registered as the holder of the share.
- 50.2 The Board may at any time give notice requiring any such person to elect either to be registered himself or to transfer the share. If the notice is not complied with within 60 days, the Board may after the expiry of that period withhold payment of all dividends and other moneys payable in respect of such share until the requirements of the notice have been complied with. Where two or more persons are jointly entitled by transmission to a share they shall for the purposes of these Articles be treated as if they were joint holders of such share registered in the order in which their names have been supplied to the Company or such other order as the person requiring to be registered may by notice to the Company have prescribed at that time.

UNTRACEABLE SHAREHOLDERS

51 POWER OF SALE

- 51.1 The Company shall be entitled to sell, at the best price reasonably obtainable at the time of sale, the shares of a member or the shares to which a person is entitled by transmission if:
- 51.1.1 the shares have been in issue throughout the period of 12 years immediately preceding the date of publication of the advertisements referred to in Article 51.1.4 below (or, if published on different dates, the earlier of such dates) (the **qualifying period**);
 - 51.1.2 at least three cash dividends (whether final or interim) have become payable in respect of the shares during the qualifying period;
 - 51.1.3 during the qualifying period, no cash dividend payable in respect of the shares has been claimed and no cheque, warrant or order sent by the Company in respect of the shares has been cashed;
 - 51.1.4 the Company has caused advertisements to be published in both a national newspaper and a newspaper circulating in the area in which the last known postal address of the member or the person entitled by transmission or the postal address at which service of notices may be effected under these Articles is located giving notice of its intention to sell the shares;
 - 51.1.5 a period of three months has elapsed from the date of the publication of the advertisements referred to in Article 51.1.4 above (or, if published on different dates, the later of such dates); and
 - 51.1.6 during the period beginning at the commencement of the qualifying period and ending on the expiry of the three month period referred to in Article 51.1.5 above, the Company has not received any communication from the member or person entitled by transmission.

- 51.2 The Company shall also be entitled to sell, at the best price reasonably obtainable at the time of sale, any additional share issued during the qualifying period in right of any share to which Article 51.1 applies (or in right of any share so issued) if the requirements of Articles 51.1.3 to 51.1.6 are satisfied in relation to the additional share (but as if references to the qualifying period were references to a period beginning on the date of allotment of the additional share and ending on the date of publication of the advertisements referred to in Article 51.1.4 (or, if published on different dates, the earlier of such dates)).
- 51.3 To give effect to any such sale, the Board may:
- 51.3.1 if the share is held in certificated form, authorise any person to sign as transferor an instrument of transfer of the share to, or in accordance with the directions of, the purchaser and such transfer shall be as effective as if it had been signed by the holder or the person entitled by transmission to the share;
- 51.3.2 if the share is held in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the share to, or in accordance with the directions of, the purchaser and such action shall be as effective as if it had been done by the holder or the person entitled by transmission to the share,

and, in each case, may cause the name of the transferee to be entered in the Register as the holder of the share which has been sold. The transferee shall not be bound to see to the application of the purchase moneys nor shall his title to the share be affected by any irregularity in, or invalidity of, the proceedings relating to the sale.

52 APPLICATION OF PROCEEDS OF SALE

The net proceeds of sale shall belong to the Company which shall be obliged to account to the former member or other person previously entitled to such shares for an amount equal to such proceeds. The Company shall enter the name of such former member or other person in the books of the Company as a creditor for such amount. No trust shall be created in respect of the debt nor shall any interest be payable in respect thereof. The Company shall not be required to account for any money earned on the net proceeds of sale, which may be employed in the Company's business or invested in such investments as the Board may from time to time think fit.

SUSPENSION OF RIGHTS ATTACHING TO SHARES

53 SUSPENSION OF RIGHTS WHERE NON-DISCLOSURE OF INTEREST

- 53.1 If any member, or any other person appearing to be interested in shares held by that member, has been duly served with a notice under section 793 of the Act (a **section 793 notice**) and the member or other person has failed in relation to any shares (the **default shares**, which expression shall include any further shares which are issued after the date of the section 793 notice in respect of those shares) to give the Company the information required by the section 793 notice within the period of 14 days from the date of service of the section 793 notice, then (unless the Board otherwise determines) the following sanctions shall apply:
- 53.1.1 the member shall not be entitled in respect of the default shares to attend or vote (either in person or by proxy) at any meeting of the Company or on a poll or to exercise any other right conferred by membership in relation to meetings of the Company; and
- 53.1.2 where the default shares represent 0.25 per cent or more in nominal value of the issued shares of any class of shares of the Company (excluding any shares of

that class held as treasury shares), the Board may in its absolute discretion by notice (a **direction notice**) to such member, and provided that the 14 day period referred to in Article 53.1 has elapsed, direct that:

53.1.2.1 any dividend or other money payable in respect of the default shares shall be withheld by the Company (without the Company being liable to pay interest on the dividend or other amount) and the member shall not be entitled to elect, pursuant to Article 139, to receive shares in lieu of dividend; and

53.1.2.2 save for an excepted transfer and subject to the requirements of the Relevant System in relation to shares in uncertificated form, no transfer of any default shares shall be registered unless:

(i) the member is not himself in default in supplying the information required; and

(ii) the member proves to the satisfaction of the Board that no person in default in supplying the information required is interested in any of the shares the subject of the transfer.

53.2 For the purpose of enforcing the sanction in Article 53.1.2.2, the Board may give notice to the member:

53.2.1 requiring the member to change any default shares held in uncertificated form into certificated form by the time stated in the notice and to keep them in certificated form for so long as the Board requires; and

53.2.2 stating that the member may not change any default shares held in certificated form into uncertificated form.

53.3 If the member does not comply with the notice, the Board may, in accordance with the uncertificated securities rules, notify the Operator that it requires the conversion of any default shares which are in uncertificated form into certificated form. Where the sanctions under Article 53.1 apply in relation to any shares, they shall cease to have effect (and any dividend or other money withheld under Article 53.1.2.1 shall become payable) at the expiry of seven days (or such shorter period as the Board may decide) following the earlier of:

53.3.1 the date on which the Company receives notification that the default shares have been transferred by means of an excepted transfer; and

53.3.2 the date on which the Company receives, in a form satisfactory to the Board, all of the information required by the relevant section 793 notice.

53.4 Where, on the basis of information obtained from a member in respect of any share held by him, the Company issues a section 793 notice to any other person, it shall at the same time send a copy of the notice to the member, but the accidental omission to do so, or the non-receipt by the member of the copy of the notice, shall not invalidate or otherwise affect the application of Article 53.1.

53.5 For the purposes of this Article 53:

53.5.1 a person, other than the member holding a share, shall be treated as appearing to be interested in that share if:

- 53.5.1.1 the member has informed the Company that the person is, or may be, so interested; or
- 53.5.1.2 the Company (after taking into account any information obtained from the member or, pursuant to a section 793 notice, from anyone else) knows or has reasonable cause to believe that the person is, or may be, so interested;
- 53.5.2 **interested** shall be construed in the same way as it is for the purpose of section 793 of the Act;
- 53.5.3 reference to a person having failed to give the Company the information required by a section 793 notice or being in default as regards supplying such information includes reference to:
 - 53.5.3.1 his having failed or refused to give all or any part of such information; and
 - 53.5.3.2 his having given information which he knows to be false in a material particular or his having recklessly given information which is false in a material particular;
- 53.5.4 an **excepted transfer** means, in relation to any shares held by a member:
 - 53.5.4.1 a transfer by way of or in pursuance of acceptance of a takeover offer (within the meaning of section 974 of the Act); or
 - 53.5.4.2 a transfer in consequence of a sale made through a recognised investment exchange (as defined in the Financial Services and Markets Act 2000) or any other stock exchange outside the United Kingdom on which the Company's shares are normally traded; or
 - 53.5.4.3 a transfer which is shown to the satisfaction of the Board to be made in consequence of a sale of the whole of the beneficial interest in the shares to a person who is unconnected with the member and with any other person appearing to be interested in the shares.
- 53.6 Nothing contained in this Article 53 shall limit the powers of the Company under section 794 of the Act.

GENERAL MEETINGS

54 ANNUAL GENERAL MEETINGS

The Board shall call and the Company shall hold general meetings as annual general meetings in accordance with the Companies Acts.

55 GENERAL MEETINGS OTHER THAN ANNUAL GENERAL MEETINGS

- 55.1 The Board may call a general meeting other than an annual general meeting whenever it thinks fit and at such time and place as the Board may determine.
- 55.2 The Board shall, on the requirement of members under the Companies Acts, call a general meeting in accordance with the requirements of the Companies Acts.
- 55.3 A general meeting may also be convened in accordance with Article 98.

- 55.4 Subject always to Article 63.3, the Board may make whatever arrangements it considers fit to allow those entitled to do so to attend and participate in any general meeting.
- 55.5 The Board shall determine in relation to each general meeting the means of attendance at and participation in the meeting, including whether the persons entitled to attend and participate in the meeting shall be enabled to do so:
- 55.5.1 (subject to Article 63.3) by means of electronic facility or facilities pursuant to Article 56 (and for the avoidance of doubt, the Board shall be under no obligation to offer or provide such facility or facilities, whatever the circumstances); and/or
- 55.5.2 by simultaneous attendance and participation at a satellite meeting place or places pursuant to Article 57.5.
- 55.6 Unless otherwise specified in the notice of meeting or determined by the chairman of the meeting, a general meeting is deemed to take place at the place where the chairman of the meeting is at the time of the meeting.
- 55.7 Two or more persons who may not be in the same place as each other attend a general meeting if their circumstances are such that if they have (or were to have) rights to speak and vote at that meeting, they are (or would be) able to exercise them.
- 55.8 A person is able to participate in a meeting if that person's circumstances are such that if he or she has (or were to have) rights in relation to the meeting, he or she is (or would be) able to exercise them.
- 55.9 In determining whether persons are attending or participating in a meeting, other than at a physical place or places, it is immaterial where any of them are or how they are able to communicate with each other.
- 55.10 A person is able to exercise the right to speak at a general meeting when that person is in a position to communicate to all those attending the meeting, during the meeting, any information or opinions which that person has on the business of the meeting.
- 55.11 A person is able to exercise the right to vote at a general meeting when:
- 55.11.1 that person is able to vote, during the meeting (or, in the case of a poll, within the time period specified by the chairman of the meeting) on resolutions put to the vote at the meeting; and
- 55.11.2 that person's vote can be taken into account in determining whether or not such resolutions are passed at the same time as the votes of all the other persons attending the meeting.
- 55.12 If, at any general meeting at which members are entitled to participate by means of electronic facility or facilities determined by the Board pursuant to Article 56, any document is required to be on display or to be available for inspection at the meeting (whether prior to or for the duration of the meeting or both), the Company shall ensure that it is available in electronic form to persons entitled to inspect it for at least the required period of time, and this will be deemed to satisfy any such requirement.

56 **SIMULTANEOUS ATTENDANCE AND PARTICIPATION BY ELECTRONIC FACILITIES**

- 56.1 Without prejudice to Article 57.5, the Board may resolve to enable persons entitled to attend and participate in a general meeting to do so partly (but not wholly) by simultaneous

attendance and participation by means of electronic facility or facilities, and may determine the means, or all different means, of attendance and participation used in relation to the general meeting. The members present in person or by proxy by means of an electronic facility or facilities (as so determined by the Board) shall be counted in the quorum for, and be entitled to participate in, the general meeting in question. That meeting shall be duly constituted and its proceedings valid if the chairman is satisfied that adequate facilities are available throughout the meeting to ensure that members attending the meeting by all means (including the means of an electronic facility or facilities) are able to:

- 56.1.1 participate in the business for which the meeting has been convened;
- 56.1.2 hear all persons who speak at the meeting; and
- 56.1.3 be heard by all other persons attending and participating in the meeting.

NOTICE OF GENERAL MEETINGS

57 NOTICE OF GENERAL MEETINGS

- 57.1 An annual general meeting and all other general meetings shall be called by at least such minimum period of notice as is required under the Companies Acts.
- 57.2 Every notice of a general meeting shall specify:
 - 57.2.1 the place (including any satellite meeting place or places determined by Article 57.5) of the meeting and the time and date of the meeting;
 - 57.2.2 in the case of an annual general meeting, that the meeting is an annual general meeting;
 - 57.2.3 the general nature of the business to be transacted at the meeting;
 - 57.2.4 the text of all resolutions to be considered by the meeting and shall state in each case whether it is proposed as an ordinary resolution or as a special resolution;
 - 57.2.5 with reasonable prominence, that a member is entitled to appoint another person as his proxy to exercise all or any of his rights to attend and to speak and vote at the meeting, that a member may appoint more than one proxy in relation to a meeting provided that each proxy is appointed to exercise the rights attached to a different share or shares held by him and that a proxy need not be a member; and
 - 57.2.6 the address of the website on which the information required by the Companies Acts is published, state the procedures with which members must comply in order to be able to attend and vote at the meeting (including the date by which they must comply), provide details of any forms to be used for the appointment of a proxy and state that a member has the right to ask questions at the meeting in accordance with the Companies Acts.
- 57.3 If pursuant to Article 56 the Board determines that a general meeting shall be held partly by means of electronic facility or facilities, the notice shall:
 - 57.3.1 include a statement to that effect;

57.3.2 specify the means, or all different means, of attendance and participation thereat, and any access, identification and security arrangements determined pursuant to Article 66; and

57.3.3 state how it is proposed that persons attending or participating in the meeting electronically should communicate with each other during the meeting.

57.4 The notice shall specify such arrangements as have at that time been made for the purpose of Article 57.5.

57.5 Without prejudice to Article 56, the Board may resolve to enable persons entitled to attend and participate in a general meeting to do so by simultaneous attendance and participation at a satellite meeting place or places anywhere in the world. The members present in person or by proxy at satellite meeting places shall be counted in the quorum for, and entitled to participate in, the general meeting in question, and the meeting shall be duly constituted and its proceedings valid if the chairman is satisfied that adequate facilities are available throughout the meeting to ensure that members attending at all the meeting places are able to:

57.5.1 participate in the business for which the meeting has been convened;

57.5.2 hear all persons who speak (whether by the use of microphones, loudspeakers, audio-visual communications equipment or otherwise) in the principal meeting place and any satellite meeting place; and

57.5.3 be heard by all other persons so present in the same way,

and the meeting shall be deemed to take place at the place where the chairman of the meeting presides (the principal meeting place, with any other location where that meeting takes place being referred in these Articles as a satellite meeting). The chairman shall be present at, and the meeting shall be deemed to take place at, the principal meeting place and the powers of the chairman shall apply equally to each satellite meeting place, including his or her power to adjourn the meeting as referred to in Article 64.

57.6 The notice of a general meeting shall be given to the members (other than any members who, under the provisions of these Articles or of any restrictions imposed on any shares, are not entitled to receive notice from the Company), to the Directors and to the Auditors provided that the Company may determine that only those persons entered on the Register at the close of business on a day determined by the Company, such day being no more than 21 days before the day that notice of the meeting is sent, shall be entitled to receive such notice.

58 **ACCIDENTAL OMISSION TO GIVE NOTICE**

The accidental omission to give notice of a general meeting or to send or supply any document or information relating to the meeting to, or the non-receipt of any such notice, document or information by, any person entitled to receive the same, whether or not the Company is aware of such omission or non-receipt, shall not invalidate the proceedings at that meeting.

59 **POSTPONEMENT OF GENERAL MEETINGS**

59.1 If, after the sending of the notice of a general meeting but before the meeting is held, or after the adjournment of a general meeting but before the adjourned meeting is held (whether or not notice of the adjourned meeting is required), the Board, in its absolute discretion, considers that it is impracticable or unreasonable for any reason to hold a general meeting

on the date or at the time or place specified in the notice calling the general meeting (including a satellite meeting to which Article 57.5 applies) and/or by means of the electronic facility or facilities specified in the notice, it may postpone the general meeting to another date, time and/or place (or in the case of a general meeting to be held at a principal meeting place and one or more satellite meeting places, to such other places) and/or change the electronic facility or facilities. If such a decision is made, the Board may then change the place (or any of the places in the case of a general meeting to which Article 57.5 applies) and/or the electronic facility or facilities and/or postpone the date and/or time again if it considers that it is reasonable to do so. No new notice of the general meeting need be sent but the Board shall take reasonable steps to ensure that notice of the change of date, time, place (or places, in the case of a general meeting to which Article 57.5 applies) of and/or electronic facility or facilities for the postponed meeting appear at the original time and at the original place (or places, in the case of a general meeting to which Article 57.5 applies) and/or on the original electronic facility or facilities. When a general meeting is so postponed, notice of the date, time and place (or places in the case of a meeting to which Article 57.5 applies), including any electronic facility if applicable, of the postponed meeting shall be given in such manner as the Board may, in its absolute discretion, determine. No business shall be transacted at any postponed meeting other than business which might properly have been transacted at the meeting had it not been postponed. Notice of the business to be transacted at such postponed meeting shall not be required. If a general meeting is postponed in accordance with this Article 50, the appointment of a proxy will be valid if it is delivered and received as required by these Articles not less than 48 hours before the time appointed for holding the postponed meeting. When calculating the 48 hour period mentioned in this Article, the Directors can decide not to take account of any part of a day that is not a working day..

PROCEEDINGS AT GENERAL MEETINGS

60 QUORUM

- 60.1 No business shall be transacted at any general meeting unless a quorum is present. The absence of a quorum shall not preclude the appointment of a chairman of the meeting in accordance with the provisions of these Articles which shall not be treated as part of the business of the meeting.
- 60.2 The quorum for a general meeting shall, for all purposes, be two members present in person or by proxy and entitled to vote on the business to be transacted at the meeting.

61 PROCEDURE IF QUORUM NOT PRESENT

- 61.1 If a quorum is not present within 15 minutes (or such longer interval as the chairman in his or her absolute discretion thinks fit) from the time appointed for holding a general meeting, or if a quorum ceases to be present during a meeting, the meeting shall be dissolved if convened on the requisition of members. In any other case, the meeting shall stand adjourned to such day (not being less than ten clear days after the date of the original meeting), and at such time and place or places, with such means of attendance and participation (including partly but not wholly by means of electronic facility or facilities), as the chairman (or, in default, the Board) may determine. If at such adjourned meeting a quorum is not present within 15 minutes from the time appointed for holding the meeting, one person entitled to vote on the business to be transacted, being a member or a proxy for a member or a duly authorised representative of a corporation which is a member, shall be a quorum and any notice of an adjourned meeting shall state this.

62 CHAIRMAN

- 62.1 The chairman of the Board or, in his absence, any deputy chairman of the Board or, in his absence, some other Director nominated by the Board shall preside as chairman at every general meeting.
- 62.2 If neither the chairman nor any deputy chairman nor such other Director (if any) is present within 5 minutes after the time appointed for the commencement of the meeting or if none of such persons is willing to act as chairman of the meeting, the Directors present shall choose one of their number to be chairman of the meeting. If only one Director is present and he is willing to act, he shall be chairman of the meeting. If no Director is willing to act as chairman or if no Director is present within 5 minutes after the time appointed for the commencement of the meeting, the members present in person or by proxy and entitled to vote shall choose one of their number to be chairman of the meeting.
- 62.3 The chairman of the meeting presiding pursuant to the provisions of this Article 62 may, at any time during a general meeting, nominate any Director to be the chairman of the meeting for the remainder of or for any part of the meeting.
- 62.4 The decision of the chairman of the meeting, made in good faith, on points of order or matters of procedure or points or matters arising incidentally out of the business of the meeting shall be final and conclusive as shall be his determination, acting in good faith, whether any point or matter is of such a nature.

63 ENTITLEMENT TO ATTEND AND SPEAK

- 63.1 A Director (and any other person invited by the chairman to do so) may attend and speak at any general meeting and at any separate meeting of the holders of any class of shares of the Company, whether or not also a member.
- 63.2 All persons seeking to attend and participate in a general meeting by way of electronic facility or facilities shall be responsible for maintaining adequate facilities to enable them to do so. Subject only to the requirement for the chairman to adjourn a general meeting in accordance with the provisions of Article 64.2, any inability of a person or persons to attend or participate in a general meeting by way of electronic facility or facilities shall not invalidate the proceedings of that meeting.
- 63.3 Nothing in these Articles authorises or allows a general meeting to be held exclusively on an electronic basis.

64 POWER TO ADJOURN

- 64.1 The chairman may, with the consent of a meeting at which a quorum is present, and shall, if so directed by the meeting, adjourn any meeting from time to time (or indefinitely) and from place to place (or, in the case of a meeting held at a principal meeting place and one or more satellite meeting places, such other places) and/or from such electronic facility or facilities for attendance and participation to such other electronic facility or facilities as the meeting shall determine. However, without prejudice to any other power which the chairman may have under these Articles (including the power to adjourn a meeting conferred by Article 64.2) or at common law, the chairman may, without the need for the consent of the meeting and before or after it has started and irrespective of whether a quorum is present, interrupt or adjourn any meeting from time to time (or indefinitely) and from place to place (or places in the case of a meeting to which Article 57.5 applies) or from electronic facility to electronic facility, or for an indefinite period, if of the opinion that it has become necessary to do so in order:

- 64.1.1 to secure the proper and orderly conduct of the meeting; or
 - 64.1.2 to give all persons entitled to do so a reasonable opportunity of attending, speaking and voting at the meeting; or
 - 64.1.3 to ensure that the business of the meeting is properly disposed of.
- 64.2 If it appears to the chairman that the facilities at the principal meeting place or any satellite meeting place or an electronic facility or facilities or security at any general meeting have become inadequate for the purposes referred to in Articles 56 or 57.5, or are otherwise not sufficient to allow the meeting to be conducted substantially in accordance with the provisions set out in the notice of meeting, then the chairman shall, without the consent of the meeting, interrupt or adjourn the general meeting.
- 64.3 All business conducted at a meeting up to the time of any adjournment shall, subject to Article 64.4, be valid.
- 64.4 The chairman may specify that only the business conducted at the meeting up to a point in time which is earlier than the time of the adjournment is valid, if in his or her opinion, to do so would be more appropriate.

65 NOTICE OF ADJOURNED MEETING

- 65.1 Any adjournment pursuant to Article 64 may, subject to the Companies Acts, be for such time and with such means of attendance and participation (including at such place or places and/or by means of such electronic facility or facilities) as the chairman (or, in default, the Board) may in his, her or its absolute discretion determine, notwithstanding that by reason of the adjournment some members may be unable to attend and participate in the adjourned meeting. Whenever a meeting is adjourned for 14 days or more or indefinitely, at least seven clear days' notice, specifying the day, the time and the place or places of the adjourned meeting and the means of attendance and participation (including by means of electronic facility or facilities if applicable) as the chairman (or, in default, the Board) may in his or her absolute discretion determine, and the general nature of the business to be transacted, shall be given in the same manner as in the case of the original meeting. Save as aforesaid and subject to the Companies Acts, no member shall be entitled to any notice of an adjournment or of the business to be transacted at any adjourned meeting.
- 65.2 No business shall be transacted at any adjourned meeting other than the business which might properly have been transacted at the meeting from which the adjournment took place.

66 ACCOMMODATION OF MEMBERS, SECURITY ARRANGEMENTS AND ORDERLY CONDUCT AT GENERAL MEETINGS

- 66.1 The Board may, for the purpose of controlling the level of attendance or ensuring the safety of those attending at any place specified for the holding of a general meeting, ensuring the security of the meeting and ensuring the future orderly conduct of the meeting, from time to time make such arrangements as it shall in its absolute discretion consider to be appropriate and may from time to time vary any such arrangements or make new arrangements therefor. Any decision made under this Article 66.1 shall be final and the entitlement of any member or proxy to attend a general meeting at such place (or places, in the case of a meeting to which Article 57.5 applies) shall be subject to any such arrangements as may be for the time being approved by the Board.
- 66.2 The Board may direct that any person wishing to attend any general meeting held at a physical place should provide evidence of identity and submit to such searches or other

security arrangements or restrictions (including restrictions in items of personal property to be taken into the meeting) as the Board shall consider appropriate in the circumstances.

- 66.3 If a general meeting is held partly by means of an electronic facility or facilities pursuant to Article 56, the Board and the chairman may make any arrangement and impose any requirement or restriction that is:
- 66.3.1 necessary to ensure the identification of those taking part by means of such electronic facility or facilities and the security of the electronic communication; and
 - 66.3.2 in its or his or her view, proportionate to those objectives.
 - 66.3.3 In this respect, the Board may authorise any voting application, system or facility for attendance and participation as it sees fit.
- 66.4 The Board shall be entitled in its absolute discretion to authorise one or more persons (including the Directors, the company secretary or the chairman) to refuse physical or electronic entry to, or eject (physically or electronically) from, any meeting any person who fails to provide such evidence of identity or to submit to such searches or to otherwise comply with such security arrangements or restrictions as are required pursuant to this Article, or who causes the meeting to become disorderly.
- 66.5 Subject to the Companies Acts (and without prejudice to any other powers vested in the chairman of a meeting) when conducting a general meeting, the chairman may make whatever arrangement and take such action or give such directions as he or she considers, in his or her absolute discretion, to be appropriate or conducive to promote the orderly conduct of the meeting, to promote the conduct of the business laid down in the notice of the meeting with reasonable despatch and to maintain good order. The chairman's decision on points of order, matters of procedure or on matters arising incidentally from the business of the meeting shall be final and conclusive, as shall his or her determination as to whether any point or matter is of such a nature.

VOTING AND POLLS

67 METHOD OF VOTING

- 67.1 A resolution put to the vote at a general meeting held partly by means of electronic facility or facilities shall be decided on a poll, which poll votes may be cast by such electronic means as the Board, in its sole discretion, deems appropriate for the purposes of the meeting. Any such poll shall be deemed to have been validly demanded at the time fixed for the holding of the meeting to which it relates. Subject thereto, at any general meeting a resolution put to a vote of the meeting shall be decided on a show of hands, unless (before or on the declaration of the result of the show of hands) a poll is duly demanded. Subject to the Companies Acts, a poll may be demanded by:
- 67.1.1 the chairman of the meeting; or
 - 67.1.2 at least five members present in person (or by proxy) and entitled to vote at the meeting; or
 - 67.1.3 a member or members present in person (or by proxy) representing at least one-tenth of the total voting rights of all the members having the right to vote at the meeting; or

67.1.4 a member or members present in person (or by proxy) holding shares conferring a right to vote at the meeting, being shares on which an aggregate sum has been paid up equal to at least one-tenth of the total sum paid up on all the shares conferring that right.

67.2 The chairman of the meeting may also demand a poll before a resolution is put to the vote on a show of hands.

67.3 At general meetings, resolutions shall be put to the vote by the chairman of the meeting and there shall be no requirement for the resolution to be proposed or seconded by any person.

68 **CHAIRMAN'S DECLARATION CONCLUSIVE ON A SHOW OF HANDS**

Unless a poll is duly demanded and the demand is not withdrawn, a declaration by the chairman of the meeting that a resolution on a show of hands has been carried, or carried unanimously or by a particular majority, or lost or not carried by a particular majority, and an entry to that effect in the book containing the minutes of proceedings of the Company, shall be conclusive evidence of that fact without proof of the number or proportion of the votes recorded for or against such resolution.

69 **OBJECTION TO OR ERROR IN VOTING**

No objection shall be raised to the qualification of any voter or to the counting of, or failure to count, any vote, except at the meeting or adjourned meeting or poll at which the vote objected to is given or tendered or at which the error occurs. Any objection made in due time shall be referred to the chairman of the meeting and shall only affect the result of the voting if, in the opinion of the chairman, it is of sufficient magnitude to affect the decision of the meeting. The decision of the chairman of the meeting in this regard shall be final and conclusive.

70 **AMENDMENTS TO RESOLUTIONS**

70.1 If an amendment to any resolution under consideration is proposed but is ruled out of order by the chairman of the meeting in good faith, any error in such ruling shall not invalidate the proceedings on the original resolution.

70.2 In the case of a resolution duly proposed as a special resolution, no amendment to it (other than an amendment to correct a patent error) may in any event be considered or voted on. In the case of a resolution duly proposed as an ordinary resolution no amendment to it (other than an amendment to correct a patent error) may be considered or voted on unless either at least 48 hours prior to the time appointed for holding the meeting or adjourned meeting at which such ordinary resolution is to be proposed, notice in writing of the terms of the amendment and intention to move the same has been lodged at the Office or received in electronic form at the electronic address at which the Company has or is deemed to have agreed to receive it or the chairman of the meeting in his or her absolute discretion decides that it may be considered or voted on.

71 **PROCEDURE ON A POLL**

71.1 Any poll duly demanded on the election of a chairman or on any question of adjournment shall be taken immediately. A poll duly demanded on any other matter shall be taken in such manner (including the use of ballot, voting papers, tickets or electronic means or any combination thereof) and at such time and place, not more than 30 days from the date of the meeting or adjourned meeting at which the poll was demanded, and by such means of attendance and participation (including at such place or places and/or by means of such electronic facility or facilities) as the chairman shall direct. The chairman may appoint

scrutineers who need not be members. It is not necessary to give notice of a poll not taken immediately if the time and place at which it is to be taken are announced at the meeting at which it is demanded. In any other case, at least seven clear days' notice shall be given specifying the time, date and place at the which the poll shall be taken. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.

- 71.2 The demand for a poll (other than on the election of a chairman or any question of adjournment) shall not prevent the continuance of the meeting for the transaction of any business other than the question on which a poll has been demanded.
- 71.3 The demand for a poll may, before the poll is taken, be withdrawn, but only with the consent of the chairman of the meeting. A demand so withdrawn validates the result of a show of hands declared before the demand was made. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.
- 71.4 On a poll votes may be given in person or by proxy. Members entitled to more than one vote need not, if they vote, use all their votes or cast all the votes they use in the same way.

72 VOTES OF MEMBERS

- 72.1 Subject to Article 72.2, the Companies Acts, to any special terms as to voting on which any shares may have been issued or may for the time being be held and to any suspension or abrogation of voting rights under these Articles, at any general meeting every member who is present in person (or by proxy) shall on a show of hands have one vote and every member present in person (or by proxy) shall on a poll have one vote for each share of which he or she is the holder.
- 72.2 On a show of hands, a duly appointed proxy has one vote for and one vote against a resolution if the proxy has been appointed by more than one member entitled to vote on the resolution and the proxy has been instructed:
- 72.2.1 by one or more of those members to vote for the resolution and by one or more other of those members to vote against it; or
- 72.2.2 by one or more of those members to vote either for or against the resolution and by one or more other of those members to use his or her discretion as to how to vote.
- 72.3 If two or more persons are joint holders of a share, then in voting on any question the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders. For this purpose, seniority shall be determined by the order in which the names of the holders stand in the Register.
- 72.4 Where in England or elsewhere a receiver or other person (by whatever name called) has been appointed by any court claiming jurisdiction in that behalf to exercise powers with respect to the property or affairs of any member on the ground (however formulated) of mental disorder, the Board may in its absolute discretion, upon or subject to production of such evidence of the appointment as the Board may require, permit such receiver or other person on behalf of such member to vote in person, on a show of hands or on a poll, by proxy on behalf of such member at any general meeting or to exercise any other right conferred by membership in relation to meetings of the Company. Evidence to the satisfaction of the Board of the authority of the person claiming to exercise the right to vote shall be deposited at the Office, or at such other place as is specified in accordance with these Articles for the deposit of instruments of proxy, at least 48 hours before the time appointed for holding the meeting

or adjourned meeting at which the right to vote is to be exercised and, in default, the right to vote shall not be exercisable.

72.5 In the case of equality of votes whether on a show of hands or on a poll, the chairman of the meeting at which the show of hands takes place or at which the poll is demanded shall not be entitled to a casting vote.

73 RESTRICTIONS ON VOTING RIGHTS

73.1 Unless the Board otherwise decides, no member shall be entitled in respect of any share held by him to vote at any meeting of the Company, either in person or by proxy, or to exercise any other right conferred by membership in relation to meetings of the Company if any call or other sum presently payable by him to the Company in respect of that share remains unpaid.

PROXIES AND CORPORATE REPRESENTATIVES

74 ENTITLEMENT TO APPOINT A PROXY

74.1 A member is entitled to appoint another person (whether a member or not) as his proxy to exercise all or any of his rights to attend and to speak and vote at a meeting of the Company. The appointment of a proxy shall not preclude a member from attending and voting in person at the meeting or any adjournment of it or on a poll.

74.2 A member may appoint more than one proxy to attend on the same occasion provided that each proxy is appointed to exercise the rights attached to a different share or shares held by him. Where a member appoints more than one proxy, the member shall:

74.2.1 specify the number of shares in respect of which each proxy is entitled to exercise the related votes; and

74.2.2 ensure that no member is appointed to exercise the votes which any other proxy has been appointed by that member to exercise.

75 RIGHTS OF PROXY

75.1 A proxy shall have the right to exercise all or any of the rights of his appointor (or, where more than one proxy is appointed, all or any of the rights attached to the shares in respect of which he is appointed the proxy) to attend, and to speak and vote at, a meeting of the Company.

75.2 The appointment of a proxy shall:

75.2.1 be deemed (subject to any contrary direction contained in the proxy appointment) to confer authority to demand or join in demanding a poll and to vote or abstain as the proxy thinks fit on any resolution or amendment of a resolution put to, or any other business which may properly come before, the meeting for which it is given; and

75.2.2 unless the contrary is stated in it, be valid for any adjournment of the meeting as well as for the meeting to which it relates.

76 METHOD AND DELIVERY OF PROXY APPOINTMENT

76.1 The Board may, if it thinks fit (but subject to the provisions of the Statutes), at the Company's expense send forms of proxy in hard copy form for use at the meeting and issue invitations

in electronic form to appoint a proxy in relation to the meeting in such form as may be approved by the Board. The appointment of a proxy shall not preclude a member from attending and voting in person at the meeting or on the poll concerned.

76.2 The appointment of a proxy shall:

76.2.1 be in writing in any usual form or in any other form which the Board may approve; and

76.2.2 signed by the appointor or his attorney duly authorised in writing or, if the appointor is a corporation, executed under its common seal or signed on its behalf by a duly authorised officer or attorney or other person duly authorised in that behalf provided that the appointment of a proxy by electronic means shall not be subject to this requirement.

76.3 In order to be valid, the appointment of a proxy must:

76.3.1 in the case of a proxy appointment made in hard copy form, be received at the Office or at such other place as may be specified by the Company for the receipt of proxy appointments in hard copy form by the relevant time together with (if required by the Board) any authority under which the proxy appointment is made or a copy of such authority certified notarially or in some other way approved by the Board; or

76.3.2 in the case of a proxy appointment made by electronic means, be received at the address specified by the Company for the receipt of proxy appointments made by electronic means by the relevant time. Any authority under which the proxy appointment is made or a copy of such authority certified notarially or in some other way approved by the Board must (if required by the Board) also be received at such address or at the Office (or at such other address or place as may be specified by the Company) by the relevant time.

76.4 For the purpose of Article 76.3, **relevant time** means:

76.4.1 in the case of a meeting or adjourned meeting, not less than 48 hours (or such shorter time as the Board may decide) before the time appointed for holding the meeting or adjourned meeting at which the person named in the proxy appointment proposes to vote; or

76.4.2 in the case of a poll taken more than 48 hours after it was demanded, not less than 24 hours (or such shorter time as the Board may decide) before the time appointed for the taking of the poll; or

76.4.3 in the case of a poll taken following the conclusion of a meeting or adjourned meeting but 48 hours or less after it was demanded, before the end of the meeting at which it was demanded (or such later time as the Board may decide).

76.5 The Board may at its discretion decide that, in calculating the periods mentioned in Article 76.4, no account shall be taken of any part of a day that is not a working day.

76.6 The Board may, in relation to any shares which are held in uncertificated form:

76.6.1 permit the appointment of a proxy to be made by electronic means in the form of an Uncertificated Proxy Instruction;

- 76.6.2 permit any supplement to, or amendment or revocation of, any Uncertificated Proxy Instruction to be made by a further Uncertificated Proxy Instruction;
- 76.6.3 prescribe the method of determining the time at which any Uncertificated Proxy Instruction is to be treated as received by the Company or such participant; and
- 76.6.4 treat any Uncertificated Proxy Instruction which purports to be, or is expressed to be, sent on behalf of a holder of a share as sufficient evidence of the authority of the person sending that instruction to send it on behalf of that holder.

77 VALIDITY OF PROXY APPOINTMENT

- 77.1 An appointment of a proxy which is not received in accordance with Article 76 shall be invalid.
- 77.2 An appointment of a proxy will cease to be valid at the expiration of 12 months from the date of its receipt, save that, unless the proxy appointment itself states otherwise, it will remain valid for use at an adjourned meeting or on a poll demanded at a meeting or an adjourned meeting where the meeting was originally held within 12 months from such date.
- 77.3 When two or more valid but differing appointments of proxy are received in respect of the same share for use at the same meeting and in respect of the same matter, the one which is last validly received shall (regardless of its date or the date of its signature) be treated as replacing and revoking the others as regards that share. If the Company is unable to determine which proxy appointment was last received, none of them shall be treated as valid in respect of that share.
- 77.4 Where the appointment of a proxy is expressed to have been or purports to have been made, sent or supplied by a person on behalf of the holder of a share:
 - 77.4.1 the Company may treat the appointment as sufficient evidence of the authority of that person to make, send or supply the appointment on behalf of that holder;
 - 77.4.2 that holder shall, if requested by or on behalf of the Company at any time, send or procure the sending of any written authority under which the appointment has been made, sent or supplied or a copy of such authority certified notarially or in some other way approved by the Board, to such address and by such time as may be specified in the request (or such address as the Company may be deemed by the Statutes to have agreed) and, if the request is not complied with in any respect, the appointment may be treated as invalid; and
 - 77.4.3 whether or not a request under Article 77.4.2 has been made or complied with, the Company may determine that it has insufficient evidence of the authority of that person to make, send or supply the appointment on behalf of that holder and may treat the appointment as invalid.

78 TERMINATION OF PROXY'S AUTHORITY

A vote cast or demand for a poll made by a proxy shall not be invalidated by the previous death or mental disorder of the member or by the revocation of the appointment of the proxy or of the authority under which the appointment was made unless written notice of the death, mental disorder or revocation shall have been received by the Company at the Office or at such other place or address as has been specified by the Company for the receipt of appointments of proxy by not later than the last time at which a proxy appointment should have been received in order to be valid for use at the meeting or adjourned meeting at which

the vote was given or the poll demanded or for use on the holding of the poll at which the vote was given.

79 CORPORATE REPRESENTATIVES

- 79.1 Any corporation (whether or not a company within the meaning of the Companies Acts) which is a member may, by resolution of its directors or other governing body, authorise a person or persons to act as its representative or representatives at any meeting of the Company. A corporation shall, for the purposes of these Articles, be deemed to be present in person at any meeting of the Company if a person so authorised by it is present at the meeting.
- 79.2 Subject to the Companies Acts, a person so authorised shall be entitled to exercise, on behalf of the corporation, the same powers as the corporation could exercise if it were an individual member of the Company.
- 79.3 The Company (or any person acting on its behalf) may require any representative of a corporation to produce a certified copy of the resolution authorising him to act as such or other satisfactory evidence of his authority before permitting him to exercise his powers.
- 79.4 A vote given or poll demanded by a proxy or by the duly authorised representative of a corporation shall be valid notwithstanding the previous determination of the authority of the person voting or demanding the poll unless notice of the determination was either delivered or received as mentioned in the following sentence at least three hours before the start of the meeting or adjourned meeting at which the vote is given or the poll demanded or (in the case of a poll taken otherwise than on the same day as the meeting or adjourned meeting) the time appointed for taking the poll. Such notice of determination shall be either by means of a document in hard copy form delivered to the Office or to such other place within the United Kingdom as may be specified by or on behalf of the Company in accordance with Article 76.3.1 or in electronic form received at the address (if any) specified by or on behalf of the Company in accordance with Article 76.3.2 or such address as the Company may be deemed by the Statutes to have agreed), regardless of whether any relevant proxy appointment was effected in hard copy form or in electronic form.

80 NO OBLIGATION TO VERIFY PROXY OR REPRESENTATIVE ACTING AS INSTRUCTED

The Company is not obliged to verify that a person appointed as a proxy for a member or authorised to act as a representative of a corporation which is a member has voted in accordance with the instructions of such member or has otherwise acted in accordance with the terms of his appointment and any failure to so vote or act shall not affect the validity of any proceedings at a meeting of the Company.

APPOINTMENT, RETIREMENT AND REMOVAL OF DIRECTORS

81 NUMBER OF DIRECTORS

- 81.1 Unless and until otherwise determined by the Company by ordinary resolution, the number of Directors (disregarding any alternate Directors) shall not be less than 2 nor more than 12.
- 81.2 A Director shall not be required to hold any shares by way of qualification.

82 POWER OF COMPANY TO APPOINT DIRECTORS

Subject to the provisions of these Articles, the Company may by ordinary resolution appoint any person who is willing to act to be a Director, either to fill a casual vacancy or as an

addition to the existing Board but the total number of Directors shall not at any time exceed any maximum number fixed by or in accordance with these Articles.

83 POWER OF BOARD TO APPOINT DIRECTORS

83.1 Subject to the provisions of these Articles, the Board may at any time appoint any person who is willing to act to be a Director, either to fill a casual vacancy or as an addition to the existing Board but the total number of Directors shall not at any time exceed any maximum number fixed by or in accordance with these Articles. . Any Director so appointed shall hold office only until the next annual general meeting and shall then be eligible for re-election but shall not be taken into account in determining the number of Directors who are to retire by rotation at such meeting.

83.2 The Board may from time to time elect a president of the Company and may determine the period for which he shall hold office. Such president may be either honorary or paid such remuneration as the Board in its discretion shall think fit, and need not be a Director but shall, if not a Director, be entitled to receive notice of and attend and speak, but not to vote, at all meetings of the Board.

84 APPOINTMENT OF EXECUTIVE DIRECTORS

84.1 The Board may from time to time appoint one or more Directors to hold any employment or executive office (including that of executive chairman, chief executive or managing director) on such terms and for such period as the Board thinks fit and, without prejudice to any claim for damages for breach of any contract entered into in any particular case, the Board may at any time revoke or terminate any such appointment.

84.2 The appointment of any Director to any executive office (including that of executive chairman, chief executive or managing director) shall automatically terminate if he ceases from any cause to be a Director, unless the contract or resolution under which he holds office expressly states otherwise.

85 ELIGIBILITY FOR APPOINTMENT AS A DIRECTOR

85.1 No person (other than a Director retiring in accordance with these Articles) shall be appointed or re-appointed as a Director at any general meeting unless:

85.1.1 he is recommended by the Board; or

85.1.2 not less than seven nor more than 42 days before the date appointed for the meeting, there has been given to the Company by a member (other than the person to be proposed) entitled to attend and vote at the meeting notice of his intention to propose a resolution for the appointment of that person (stating the particulars which would, if he were so appointed, be required to be included in the Company's register of directors) and a notice signed by that person of his willingness to be appointed.

86 RESOLUTION FOR APPOINTMENT OF TWO OR MORE DIRECTORS

A resolution for the appointment of two or more persons as Directors by a single resolution shall not be proposed at any general meeting unless an ordinary resolution that it shall be so proposed has first been agreed to by the meeting without any vote being given against it. Any resolution proposed in contravention of this Article shall be void.

87 APPOINTMENT AND RETIREMENT OF DIRECTORS

87.1 At each annual general meeting of the Company any Director then in office:

87.1.1 Who has been appointed by the Board since the previous annual general meeting in accordance with Article 84.1; or

87.1.2 For whom it is the third annual general meeting following the annual general meeting at which he or she was elected or last re-elected;

shall retire from office but shall be eligible for re-appointment.

87.2 A Director who retires at an annual general meeting shall (unless he or he is removed from office or his or her office is vacated in accordance with these Articles) retain office until the close of the meeting at which he or she retires or (if earlier) when a resolution is passed at that meeting not to fill the vacancy or to elect another person in his or her place or the resolution to re-appoint him or her is put to the meeting and lost.

87.3 If the Company, at any meeting at which a Director retires in accordance with these Articles does not fill the office vacated by such Director, the retiring Director, if willing to act, shall be deemed to be re-appointed unless at that meeting a resolution is passed not to fill the vacancy or elect another person in his or her place or unless the resolution to re-appoint him or her is put to the meeting and lost.

87.4 If:

87.4.1 at the annual general meeting in any year any resolution or resolutions for the appointment or re-appointment of the persons eligible for appointment or re-appointment as Directors are put to the meeting and lost; and

87.4.2 at the end of that meeting the number of Directors is fewer than any minimum number of Directors required under Article 81.1.

All retiring Directors who stood for re-appointment at that meeting (**Retiring Directors**) shall be deemed to have been re-appointed as Directors and shall remain in office but the Retiring Directors may only act for the purpose of filling vacancies, convening general meetings of the Company and performing such duties as are essential to maintain the Company as a going concern, and not for any other purpose.

87.5 The Retiring Directors shall convene a general meeting as soon as reasonably practicable following the meeting referred to in Article 87.4 and they shall retire from office at that meeting. If at the end of any meeting convened under this Article the number of Directors is fewer than any minimum number of Directors required under Article 81.1, the provisions of this Article shall also apply to that meeting.

88 REMOVAL BY ORDINARY RESOLUTION

In addition to any power of removal conferred by the Companies Acts, the Company may by ordinary resolution of which special notice has been given remove any Director from office notwithstanding any provision of these Articles or of any agreement between the Company and such Director, but without prejudice to any claim for damages which he may have for breach of any such agreement, and appoint another person in place of a Director so removed from office. In default of such appointment, the vacancy arising upon the removal of a Director from office may be filled as a casual vacancy.

89 VACATION OF OFFICE

- 89.1 The office of a Director shall be vacated if:
- 89.1.1 he resigns by notice in writing to the Company delivered to the Secretary at the Office or at an address specified by the Company for the purpose of communication by electronic means or tendered at a meeting of the Board;
 - 89.1.2 he offers to resign by notice in writing to the Company delivered to the Secretary at the Office or at an address specified by the Company for the purpose of communication by electronic means or tendered at a meeting of the Board and the Board resolves to accept such offer;
 - 89.1.3 he ceases to be a Director by virtue of any provision of the Companies Acts, is removed from office pursuant to these Articles or the Companies Acts or becomes prohibited by law from acting as a Director;
 - 89.1.4 he becomes bankrupt, has an interim receiving order made against him, makes any arrangement with or compounds with his creditors generally or applies to the court for an interim order under the Insolvency Act 1986 in connection with a voluntary arrangement under that Act;
 - 89.1.5 he is, or may be, suffering from mental disorder or is otherwise incapable of managing his affairs and either:
 - 89.1.5.1 an order is made by any court or official having jurisdiction (whether in the United Kingdom or elsewhere) in matters concerning mental disorder for his detention or for the appointment of a receiver, curator bonis or other person to exercise powers with respect to his property or affairs; or
 - 89.1.5.2 he is admitted to hospital following an application for admission for treatment under the Mental Health Act 1983 or any similar legislation in any other jurisdiction,
 - 89.1.5.3 and the Board resolves that his office be vacated;
 - 89.1.6 he is absent from meetings of the Board for a period of six consecutive months without the permission of the Board and his alternate Director (if any) has not attended in his place during that period and the Board resolves that his office be vacated;
 - 89.1.7 (without prejudice to any claim for damages which he may have for breach of any contract between him and the Company) he is removed from office by a notice in writing addressed to him at his last known address signed by at least three-fourths in number of the other Directors (and, for this purpose, a set of like notices each signed by one or more Directors shall be as effective as a single notice signed by the requisite number of Directors); or
 - 89.1.8 in the case of any Director who holds any executive office with the Company, his appointment as such is terminated or expires and the Board resolves that his office be vacated.
- 89.2 A resolution of the Board declaring a Director to have vacated office under the terms of this Article 89 shall be conclusive as to the fact and grounds of vacation stated in the resolution.

- 89.3 If the office of a Director is vacated for whatever reason, he shall cease to be a member of any committee.

ALTERNATE DIRECTORS

90 APPOINTMENT AND TERMINATION OF APPOINTMENT OF AN ALTERNATE DIRECTOR

- 90.1 A Director may at any time appoint any other person (including another Director) to be his alternate and may at any time remove from office an alternate Director so appointed. Unless the appointment has previously been approved by the Board or unless the appointee is another Director, the appointment of an alternate Director shall not be effective until the appointment has been approved by the Board.

- 90.2 An alternate Director ceases to be an alternate Director:

- 90.2.1 if his appointor revokes his appointment; or
- 90.2.2 (in the case of an alternate Director who is not a Director) if the Board by resolution revokes its approval of him; or
- 90.2.3 if his appointor ceases for any reason to be a Director provided that, if a Director retires but is re-appointed or is deemed to be re-appointed at the meeting at which he retires, any appointment by such Director of an alternate Director made by him which was in force immediately prior to his retirement shall remain in force after his re-appointment; or
- 90.2.4 on the happening of any event which, if he were a Director otherwise appointed, would cause him to vacate his office as a Director; or
- 90.2.5 if he resigns his office by notice in writing to the Company.

- 90.3 Any appointment or removal of an alternate Director shall be effected on receipt by the Company of notice to the Company signed by the Director making or revoking the appointment and sent to or received by the Company at the Office or at an address specified by the Company for the purpose of communication by electronic means or tabled at a meeting of the Board or in any other manner approved by the Board.

91 RIGHTS AND RESPONSIBILITIES OF AN ALTERNATE DIRECTOR

- 91.1 Every alternate Director is (subject to his giving to the Company an address at which notices may be served on him) entitled to receive notice of all meetings of the Board (except when absent from the United Kingdom) and of all committees of which the Director appointing him is a member. In his appointor's absence from such meetings, an alternate Director is entitled to attend and vote at such meetings and to exercise all the powers, rights, duties and authorities of his appointor.

- 91.2 A Director or any other person may act as alternate Director to represent more than one Director and an alternate Director shall be entitled at meetings of the Board or any committee to one vote for every Director for whom he is acting as alternate in addition to his own vote if he is also a Director, but he shall count as only one for the purpose of determining whether a quorum is present.

- 91.3 The signature of an alternate Director to a resolution in writing of the Directors is as effective as the signature of the Director who appointed him unless the notice of his appointment

provides otherwise. To such extent as the Board may from time to time determine in relation to any committee of the Board the provisions of Articles 91.1 and this Article 91.3 shall also apply to any meeting of any such committee of which his appointor is a member.

- 91.4 Subject to the provisions of the Companies Acts, an alternate Director is entitled to contract and to be interested in and benefit from transactions or arrangements, to be paid expenses and to be indemnified to the same extent as if were a Director. However, an alternate Director is not entitled to receive any remuneration from the Company for serving as an alternate Director, except such part (if any) of the remuneration otherwise payable to the Director who appointed him as the appointing Director may direct by notice in writing to the Company.
- 91.5 An alternate Director is an officer of the Company but, except to the extent set out in these Articles, he does not have the power to act as a Director and is not deemed to be a Director for the purposes of these Articles.
- 91.6 An alternate Director is alone responsible to the Company for his own acts and defaults and is not deemed to be the agent of the Director who appointed him.

DIRECTORS' REMUNERATION, EXPENSES AND PENSIONS

92 DIRECTORS' FEES

- 92.1 The Directors (other than alternate Directors and any Director who for the time being holds any employment or executive office with the Company or a subsidiary of the Company) shall be paid out of the funds of the Company by way of remuneration for their services as directors of the Company, such fees not exceeding in aggregate £500,000 per annum (or such other sum as the Company may by ordinary resolution determine), as the Board may decide. Such fees shall be divided among the Directors in such proportions and in such manner as the Board may decide or, in default of such determination, equally (except that, in such event, any Director holding office for less than the whole of the relevant period in respect of which the fees are paid shall only rank in such division in proportion to the time during such period for which he holds office).
- 92.2 Any fees payable pursuant to this Article 92 shall be distinct from any salary, remuneration or other amounts payable to a Director under any other provisions of these Articles and shall accrue from day to day.

93 ADDITIONAL REMUNERATION

- 93.1 Any Director who performs any special or extra services which in the opinion of the Board are outside the scope of his ordinary duties as a director of the Company and not in his capacity as a holder of employment or executive office may be paid such additional remuneration as the Board may decide.
- 93.2 Such additional remuneration may be by way of lump sum, salary, commission, participation in profits or otherwise as the Board may decide.

94 REMUNERATION OF EXECUTIVE DIRECTORS

The salary or remuneration of any Director appointed to hold any employment or executive office in accordance with the provisions of these Articles shall be such as the Board may from time to time decide and may be either a fixed sum of money or may altogether or in part be governed by business done or profits made or otherwise decided by the Board. Any such salary or remuneration may be in addition to or in lieu of any fees payable to the Director for his services as a director of the Company under these Articles.

95 REIMBURSEMENT OF EXPENSES

Each Director shall be entitled to be repaid all reasonable travelling, hotel and other expenses properly incurred by him in or about the performance of his duties as a director of the Company, including any expenses incurred in attending meetings of the Board or of any committees or meetings of the Company.

96 PENSIONS AND OTHER BENEFITS

96.1 The Board may exercise all the powers of the Company to provide pensions or other retirement or superannuation benefits, death or disability benefits or other allowances or gratuities (whether by insurance or otherwise) to or for the benefit of any person who is or has at any time been a director, officer or employee of:

96.1.1 the Company; or

96.1.2 any body corporate which is or was a subsidiary undertaking of the Company; or

96.1.3 any body corporate which is or was allied to or associated with the Company or a subsidiary undertaking of the Company; or

96.1.4 a predecessor in business of the Company or a subsidiary undertaking of the Company, and for any member of his family (including a spouse, a former spouse, a civil partner and a former civil partner) and any person who is or was dependent on him.

96.2 For such purpose, the Board may establish, maintain, subscribe and contribute to any scheme, institution, association, club, trust or fund and pay premiums. The Board may procure any of the foregoing matters to be done by the Company, either alone or in conjunction with any other person.

96.3 Any Director or former Director shall be entitled to receive and retain for his own benefit any benefit provided under this Article 96 and shall not be obliged to account for it to the Company. The receipt of any such benefit shall not disqualify any person from being or becoming a Director.

POWERS AND DUTIES OF DIRECTORS

97 GENERAL POWERS

97.1 Subject to the provisions of the Companies Acts and these Articles and to any directions given by special resolution of the Company, the business and affairs of the Company shall be managed by the Board which may exercise all the powers of the Company whether relating to the management of the business or not.

97.2 No alteration of these Articles and no direction given by special resolution of the Company shall invalidate any prior act of the Board which would have been valid if that alteration had not been made or that direction had not been given.

97.3 The general powers given by this Article 97 shall not be limited or restricted by any specific authority or power given to the Board by any other Article.

98 POWER OF DIRECTORS IF NUMBER FALLS BELOW MINIMUM

If the number of Directors is less than the minimum for the time being prescribed by these Articles, the remaining Director or Directors shall act only for the purpose of:

- 98.1.1 appointing an additional Director or Directors to make up such minimum; or
- 98.1.2 convening a general meeting for the purpose of making such appointment.

If there is no Director or if no Director or Directors are able or willing to act, then any two members may summon a general meeting for the purpose of appointing Directors.

99 **DELEGATION TO INDIVIDUAL DIRECTORS**

The Board may delegate or entrust to and confer on any Director any of its powers, authorities and discretions (with power to sub-delegate) for such time, on such terms and subject to such conditions as it thinks fit. The Board may confer such powers either collaterally with, or to the exclusion of and in substitution for, all or any of the powers of the Board in that respect and may from time to time revoke, withdraw, alter or vary all or any such powers.

100 **DELEGATION TO COMMITTEES**

100.1 The Board may delegate (with power to sub-delegate) any of its powers, authorities and discretions (including all powers, authorities and discretions relating to the remuneration of or benefits conferred on the Directors or any of them) for such time, on such terms and subject to such conditions as the Board thinks fit to any committee consisting of one or more Directors and (if thought fit) one or more other persons provided that:

- 100.1.1 a majority of the members of the committee shall be Directors; and
- 100.1.2 no resolution of the committee shall be effective unless a majority of those present when it is passed are Directors.

The Board may confer such powers either collaterally with, or to the exclusion of and in substitution for, all or any of the powers of the Board in that respect and may from time to time revoke, withdraw, alter or vary all or any of such powers and discharge any such committee in whole or in part.

100.2 Where any power, authority or discretion of the Board is delegated to a committee authorised by the Board, any reference in these Articles to the exercise by the Board of such power, authority or discretion shall be construed as if it were a reference to the exercise of such power, authority or discretion by such committee.

100.3 The power to delegate contained in this Article 100 shall be effective in relation to the powers, authorities and discretions of the Board generally and shall not be limited by the fact that in certain Articles, but not in others, express reference is made to particular powers, authorities or discretions being exercised by the Board or by a committee.

100.4 All committees shall, in the exercise of the powers delegated to them and in the transaction of business, conform to any mode of proceedings and regulations which may be prescribed by the Board. Subject thereto, the proceedings of any committee shall be governed by the provisions of these Articles regulating the proceedings of the Board, so far as they are capable of applying.

101 **LOCAL AND DIVISIONAL MANAGEMENT**

101.1 The Board may establish any local or divisional boards or agencies for managing any of the affairs of the Company in any locality (whether in the United Kingdom or elsewhere) in relation to any business, and may appoint any person to be a member of any such local or divisional board, or a manager or agent, and may fix his remuneration. Any such appointment

may be made for such time, on such terms and subject to such conditions as the Board thinks fit. The Board may from time to time remove any person so appointed.

101.2 The Board may delegate to any local or divisional board, manager or agent any of its powers, authorities and discretions (with power to sub-delegate) and may authorise the members of any local or divisional board, or any of them, to fill any vacancies and to act notwithstanding vacancies. Any such delegation may be made for such time, on such terms and subject to such conditions as the Board thinks fit. The Board may confer such powers either collaterally with, or to the exclusion of and in substitution for, all or any of the powers of the Board in that respect and may from time to time revoke, withdraw, alter or vary all or any of such powers.

101.3 Subject to any terms and conditions expressly imposed by the Board, the proceedings of any local or divisional board or agency with two or more members shall be governed by the provisions of these Articles regulating the proceedings of the Board, so far as they are capable of applying.

102 **AGENTS**

The Board may, by power of attorney or otherwise, appoint any person or persons to be the agent of the Company and may delegate to any such person or persons any of its powers, authorities and discretions (with power to sub-delegate), in each case for such purposes and for such time, on such terms (including as to remuneration and the protection and convenience of persons dealing with the agent) and subject to such conditions as the Board thinks fit. The Board may confer such powers either collaterally with, or to the exclusion of and in substitution for all or any of the powers of the Board in that respect and may from time to time revoke, withdraw, alter or vary all or any of such powers.

103 **EXERCISE OF VOTING RIGHTS**

The Board may exercise or cause to be exercised the voting rights conferred by shares in any other company held or owned by the Company, or any power of appointment to be exercised by the Company, in such manner in all respects as it thinks fit (including the exercise of the voting rights or power of appointment in favour of the appointment of any Director as a director or other officer or employee of such company or in favour of the payment of remuneration to the directors, officers or employees of such company).

104 **PROVISION FOR EMPLOYEES**

The Board may exercise any power conferred on the Company by the Companies Acts to make provision for the benefit of persons employed or formerly employed by the Company or any of its subsidiaries in connection with the cessation or the transfer to any person of the whole or part of the undertaking of the Company or that subsidiary.

105 **SIGNING OF CHEQUES ETC.**

All cheques, promissory notes, drafts, bills of exchange and other negotiable or transferable instruments, and all receipts for moneys paid to the Company, shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, in such manner as the Board shall from time to time decide.

106 **OVERSEAS REGISTERS**

Subject to the provisions of the Companies Acts, the Board may exercise the powers conferred on the Company with regard to the keeping of an overseas, local or other register

in any territory and may make and vary such regulations as it thinks fit regarding the keeping of any such register.

107 **OFFICES INCLUDING THE TITLE 'DIRECTOR'**

The Board may appoint any person (other than a Director) to any office or employment with the Company having a designation or title which includes the word 'director' or attach to any existing office or employment with the Company such a designation or title and may at any time terminate any such appointment or the use of such designation or title. The inclusion of the word **director** in the designation or title of the office or employment of any person shall not imply that such person is, or is deemed to be, or is empowered in any respect to act as, a director of the Company for any of the purposes of the Companies Acts or these Articles. Subject as aforesaid, the powers and duties of any such person shall be determined by the Board.

108 **BORROWING POWERS**

108.1 Subject as provided in these Articles and to the provisions of the Companies Acts, the Board may exercise all the powers of the Company:

108.1.1 to borrow money;

108.1.2 to mortgage or charge all or any part of its undertaking, property and assets (both present and future) and uncalled capital; and

108.1.3 to issue debentures and other securities, whether outright or as collateral security for any debt, liability or obligation of the Company or of any third party.

108.2 The Board shall restrict the borrowings of the Company and shall exercise all voting and other rights or powers of control exercisable by the Company in relation to its subsidiary undertakings (if any) so as to secure (but, as regards subsidiary undertakings, only so far as by the exercise of such rights or powers of control the Board can secure) that the aggregate principal amount outstanding at any time of all borrowings by the Group (exclusive of borrowings owing by one Group company to another Group company, other than amounts to be taken into account in accordance with Article 108.4) after deducting cash deposited shall not, save with the previous sanction of an ordinary resolution of the Company, exceed a sum equal to five times the adjusted capital and reserves.

108.3 For the purposes of this Article 108:

108.3.1 **adjusted total of capital and reserves** means the aggregate of:

108.3.1.1 the amount paid up or credited as paid up on the allotted or issued share capital of the Company (including any shares held as treasury shares); and

108.3.1.2 the amount standing to the credit of the consolidated reserves of the Group (including any share premium account, capital redemption reserve and revaluation reserve) after adding or deducting the amount standing to the credit or debit of the Group's profit and loss account, all as shown in the relevant audited balance sheet, but after:

108.3.1.3 making such adjustments as may be appropriate in respect of any variation in the amount of the paid up share capital and the amount of any of such reserves since the date of the relevant balance sheet and

so that, for this purpose, if any proposed allotment of shares by the Company for cash has been underwritten or agreed to be subscribed, then those shares shall be deemed to have been allotted and the amount (including any premium) of the subscription moneys payable in respect of those shares (not being moneys payable later than six months after the date of allotment) shall be deemed to have been paid up on the date when the issue of the shares was underwritten or agreed to be subscribed (or, if the underwriting or subscription was conditional, the date on which it became unconditional);

- 108.3.1.4 making such adjustments as may be appropriate in respect of any variation in the interests of the Company in its subsidiary undertakings (including a variation whereby an undertaking becomes, or ceases to be, a subsidiary undertaking of the Company) since the date of the relevant balance sheet;
 - 108.3.1.5 if the calculation is required for the purposes of or in connection with a transaction under or in connection with which any undertaking is to become or cease to be a subsidiary undertaking of the Company, making all such adjustments as would be appropriate if such transaction had been carried into effect;
 - 108.3.1.6 excluding (so far as not already excluded) any amounts attributable to minority interests in subsidiary undertakings and any amounts set aside for taxation (other than deferred taxation);
 - 108.3.1.7 deducting the amount of any distribution declared, recommended or made by a Group company to a person other than another Group company out of profits accrued up to and including the date of (and to the extent not provided for in) the relevant balance sheet; and
 - 108.3.1.8 deducting any amounts attributable to goodwill or other intangible assets shown in the relevant balance sheet; and (ix) making such other adjustments (if any) as the Auditors may consider appropriate.
- 108.3.2 **borrowings** include the following except insofar as otherwise taken into account:
- 108.3.2.1 the principal amount outstanding of any debenture (whether secured or unsecured) allotted or issued by a Group company (whether for cash or otherwise) owned otherwise than by a Group company;
 - 108.3.2.2 the principal amount raised by any Group company by acceptances under any acceptance credit opened on its behalf and in its favour by any bank or acceptance house (not being a Group company) but excluding acceptances relating to the purchase of goods or services in the ordinary course of trading which are outstanding for six months or less;
 - 108.3.2.3 the nominal amount of any allotted or issued and paid up share capital, and the principal amount of any debenture or other borrowings of, any person, the redemption or repayment of which is guaranteed or secured (or is the subject of an indemnity granted) by a Group company but excluding any such share capital which is owned by, and any such borrowings which are owed to, a Group company;

- 108.3.2.4 the nominal amount of any allotted or issued and paid up share capital (other than equity share capital) of any subsidiary undertaking of the Company owned otherwise than by a Group company;
 - 108.3.2.5 any fixed or minimum premium payable on final redemption or repayment of any borrowing or deemed borrowing;
 - 108.3.2.6 any amount in respect of a finance lease payable by a Group company which would be shown as an obligation in a balance sheet prepared in accordance with the accounting principles used in the preparation of the relevant balance sheet; and
 - 108.3.2.7 any part of the purchase price of any movable or immovable asset acquired by a Group company, the payment of which is deferred beyond the date of completion of the transfer of the legal title to such asset or, if no such transfer is to take place by the date which is six months after the contract for purchase is entered into or (if later) becomes unconditional, beyond that date, but shall exclude:
 - 108.3.2.8 borrowings by a Group company for the purpose of repaying, within six months of the borrowing, the whole or any part of any borrowings of that or another Group company, pending their application for that purpose during that period;
 - 108.3.2.9 borrowings by a Group company to finance a contract in respect of which any part of the price receivable under the contract by that or another Group company is guaranteed or insured by any government, governmental agency or body or by a person (not being a Group company) carrying on the business of providing credit insurance, up to an amount not exceeding that part of the price receivable under the contract which is so guaranteed or insured; and
 - 108.3.2.10 an amount equal to the borrowings of a Group company outstanding immediately after it became a subsidiary undertaking of the Company and an amount secured on an asset immediately after it was acquired by a Group company but only until six months after the date on which the Group company became a subsidiary undertaking or, as the case may be, the asset was acquired;
- 108.3.3 **cash deposited** means an amount equal to the aggregate for the time being of all cash deposits with any bank or other person (not being a Group company), the realisable value of any certificates issued by governments and companies and other readily realisable deposits which are owned by a Group company and which would be shown as a current asset in a balance sheet prepared in accordance with the accounting principles used in the preparation of the relevant balance sheet save that, in the case of any such items owned by a partly-owned subsidiary undertaking of the Company, there shall be excluded the proportion of such items which corresponds to the outside interests;
- 108.3.4 **excepted foreign currency borrowings** means borrowings denominated or repayable in a currency other than sterling which are covered by an exchange cover scheme, forward currency contract, currency option, back- to-back loan, swap or other arrangement taken out or entered into to reduce the risks associated with fluctuations in exchange rates;

- 108.3.5 **finance lease** means a contract between a lessor and a Group company as lessee or sub-lessee where substantially all the risks and rewards of the ownership of the asset leased or sub-leased are to be borne by the lessee or sub-lessee;
- 108.3.6 **Group** means the Company and its subsidiary undertakings from time to time and **Group company** means any undertaking in the Group;
- 108.3.7 **outside interests** means, in relation to a partly-owned subsidiary undertaking of the Company, the proportion of its issued equity share capital which is not attributable, directly or indirectly, to the Company; and
- 108.3.8 **relevant balance sheet** means the latest audited consolidated balance sheet of the Company and its subsidiary undertakings but, where the Company has no subsidiary undertakings, it means the latest audited balance sheet of the Company and, where the Company has subsidiary undertakings but there are no consolidated accounts of the Group, it means the respective latest audited balance sheets of the undertakings comprising the Group.
- 108.4 In the calculation of the aggregate principal amount of borrowings for the purposes of this Article 108:
- 108.4.1 in the case of borrowings by a partly-owned subsidiary undertaking of the Company and not owing to another Group company, there shall be excluded the proportion of such borrowings which corresponds to the outside interests;
- 108.4.2 in the case of borrowings by a Group company and owing to a partly-owned subsidiary undertaking of the Company, there shall be included the proportion of such borrowings which corresponds to the outside interests;
- 108.4.3 in the case of borrowings by a partly-owned subsidiary undertaking of the Company and owing to another partly-owned subsidiary undertaking of the Company, the amount of such borrowings to be included in the calculation by virtue of paragraph 108.4.2 of this Article 108.4 shall be reduced by the exclusion therefrom of the proportion of such amount which corresponds to the outside interests in the partly-owned subsidiary undertaking which is the borrower;
- 108.4.4 no amount shall be taken into account more than once in any calculation of borrowings; and
- 108.4.5 any borrowings denominated or repayable, or any cash deposited, in a currency other than sterling shall:
- 108.4.5.1 with the exception of excepted foreign currency borrowings, be converted into sterling at the rate of exchange in London at the close of business on the last working day before the date on which the calculation is made or, if it would result in a lower figure, at the rate of exchange in London at the close of business on the date of the relevant balance sheet and so that, for this purpose, the rate of exchange in London shall be taken as the spot rate quoted by a bank in London selected by the Board for the purchase by the Company of the currency and amount in question for sterling; and
- 108.4.5.2 in the case of any excepted foreign currency borrowings, be converted into sterling at the rate of exchange applicable to such borrowings on

their repayment to the extent that such rate is fixed under the exchange cover scheme or other arrangement covering such borrowings provided that, where it is not possible to determine such rate, such borrowings shall be converted into sterling on such basis as may be agreed with or determined by the Auditors or, in the absence of any such agreement or determination, in accordance with subparagraph 108.4.5.1 above.

108.5 A certificate or report by the Auditors:

108.5.1 as to the amount of adjusted capital and reserves or the amount of borrowings for the purpose of this Article 108; or

108.5.2 to the effect that the limit imposed under this Article 108 has not been or will not be exceeded or breached at any particular time or times or as a result of any particular transaction or transaction, shall be conclusive evidence of such amount or fact.

108.6 No person dealing with the Company or any of its subsidiary undertakings shall be concerned to see or inquire whether the limit imposed by this Article 108 is observed and no debt incurred or security given in excess of such limit shall be invalid or ineffectual unless the lender or the recipient of the security had, at the time when the debt was incurred or security given, express notice that such limit had been or would thereby be exceeded.

PROCEEDINGS OF DIRECTORS

109 MEETINGS OF THE BOARD

109.1 Subject to the provisions of these Articles, the Board may meet for the despatch of business, adjourn and otherwise regulate its proceedings as it thinks fit.

109.2 At any time, a Director may, and the Secretary at the request of a Director shall, summon a meeting of the Board.

110 NOTICE OF MEETING OF THE BOARD

110.1 Notice of a meeting of the Board may be given to a Director personally or by word of mouth or sent in hard copy form or by electronic means to him at an address specified by him to the Company for this purpose (or, if no such address has been specified, at his last known address).

110.2 A Director may waive notice of any meeting of the Board either prospectively or retrospectively.

110.3 It shall not be necessary to give notice of a meeting of the Board to any Director who is for the time being absent from the United Kingdom unless he has requested the Board to do so, in which case notices of meetings of the Board shall during his absence be sent to him in hard copy form or in electronic form to such address (if any) notified by him to the Company for that purpose but such notices need not be given any earlier than notices given (by whatever means) to Directors not so absent.

111 QUORUM

111.1 The quorum necessary for the transaction of business of the Board may be determined by the Board and, unless so determined at any other number, shall be two. A person who holds

office only as an alternate Director shall, if his appointor is not present, be counted in the quorum.

- 111.2 A duly convened meeting of the Board at which a quorum is present shall be competent to exercise all or any of the powers, authorities and discretions for the time being vested in or exercisable by the Board.

112 **CHAIRMAN OF THE BOARD**

- 112.1 The Board may appoint one of its body as chairman of the Board and, if thought fit, one or more deputy chairmen and may determine the period for which each is to hold office (and may at any time remove him or them from office). The chairman of the Board, failing whom a deputy chairman, shall preside at all meetings of the Board. If no such chairman of the Board or deputy chairman is appointed or if at any meeting neither the chairman of the Board nor a deputy chairman is present within five minutes after the time appointed for the commencement of the meeting, the Directors and (in the absence of their appointors) alternate Directors present shall choose one of their number to be chairman of the meeting.

- 112.2 In the absence of the chairman of the Board at any meeting of the Board, if two or more deputy chairmen are present, the deputy chairman to act as chairman of the meeting shall be decided by those Directors and (in the absence of their appointors) alternate Directors present.

- 112.3 Any chairman of the Board or deputy chairman may also hold executive office under the Company.

113 **VOTING**

Questions arising at any meeting of the Board shall be determined by a majority of votes. In the case of an equality of votes, the chairman of the meeting shall have a second or casting vote.

114 **PARTICIPATION BY TELEPHONE OR VIDEO CONFERENCE**

- 114.1 Any Director or alternate Director may validly participate in a meeting of the Board or a committee by means of conference telephone, video conferencing link or any other form of communications equipment provided that all persons participating in the meeting are able to hear and speak to each other throughout the meeting.

- 114.2 A person so participating shall be deemed to be present in person at the meeting and shall accordingly be counted in the quorum and be entitled to vote. The meeting shall be deemed to take place where the largest group of those participating is assembled or, if there is no group which is larger than any other group, where the chairman of the meeting is.

115 **RESOLUTION IN WRITING**

- 115.1 A resolution in writing signed or confirmed electronically by all the Directors for the time being entitled to receive notice of a Board meeting and to vote on the resolution and not being less than a quorum (or by all the members of a committee of the Board for the time being entitled to receive notice of such committee meeting and to vote on the resolution and not being less than a quorum of that committee), shall be as valid and effective for all purposes as a resolution duly passed at a meeting of the Board (or committee, as the case may be).

115.2 Such a resolution may consist of several documents or electronic communications in the same form each signed or authenticated by one or more of the Directors or members of the relevant committee.

116 VALIDITY OF PROCEEDINGS

All acts done by, or in pursuance of a resolution of, a meeting of the Board or of a committee or by a person acting as a Director, alternate Director or member of a committee shall, notwithstanding that it is afterwards discovered that:

116.1.1 there was some defect in the appointment of any Director, alternate Director or member of a committee; or

116.1.2 any such person was disqualified from holding office or had vacated office or was not entitled to vote,

be as valid as if every such person had been duly appointed and was duly qualified and had continued to be a Director, alternate Director or member of a committee and had been entitled to vote.

DIRECTORS' INTERESTS AND CONFLICTS OF INTEREST

117 AUTHORISATION OF CONFLICTS OF INTEREST

117.1 The Board may, subject to the quorum and voting requirements set out in this Article 117, authorise any situation or matter in which a Director (an **Interested Director**) has, or can have, a direct or indirect interest which conflicts, or possibly may conflict, with the interests of the Company and which would, if not so authorised, result in the Interested Director being in breach of his duty under section **175** of the Act (a **Conflict Situation**).

117.2 An Interested Director seeking authorisation of a Conflict Situation:

117.2.1 must declare to the Board the nature and extent of his interest giving rise to the Conflict Situation as soon as is reasonably practicable; and

117.2.2 must provide the Board with all such information as is necessary to enable the Board to decide whether or not to authorise the Conflict Situation together with such additional information as may be requested by the Board.

117.3 Any Director (including the Interested Director) may propose that a Conflict Situation be authorised by the Board. Any such proposal and any authorisation given by the Board shall be effected in the same way that any other matter may be proposed to and resolved upon by the Board under the provisions of these Articles save that:

117.3.1 the Interested Director and any other Director with an interest in the Conflict Situation shall not count towards the quorum nor vote on any resolution giving such authorisation; and

117.3.2 the Interested Director and any other Director with an interest in the Conflict Situation may, if the other members of the Board so decide, be excluded from any meeting of the Board while the Conflict Situation is under consideration.

117.4 Where the Board authorises a Conflict Situation:

- 117.4.1 the Board may (whether at the time of giving the authorisation or subsequently):
 - 117.4.1.1 require that the Interested Director is excluded from the receipt of information and documentation, participation in discussions and/or the making of decisions (whether at meetings of the Board or otherwise) concerning the Conflict Situation or any matter in relation to which the Conflict Situation is relevant; and/or
 - 117.4.1.2 impose upon the Interested Director such other terms for the purpose of dealing with the Conflict Situation as the Board may decide;
 - 117.4.2 the Interested Director will be obliged to conduct himself in accordance any terms imposed by the Board in relation to the Conflict Situation;
 - 117.4.3 the terms of authorisation must be recorded in writing (but the authorisation will be effective whether or not the terms are so recorded); and
 - 117.4.4 the Board may revoke or vary the authorisation at any time but any such revocation or variation will not affect anything done or omitted to be done by the Interested Director prior to such revocation or variation in accordance with the terms of such authorisation.
- 117.5 Any authorisation of a Conflict Situation pursuant to this Article shall extend to any conflict of interest or possible conflict of interest which may reasonably be expected to arise out of the Conflict Situation so authorised.

118 **CONFIDENTIAL INFORMATION AND ATTENDANCE AT MEETINGS OF THE BOARD**

- 118.1 Subject to Article 118.2, if a Director obtains or has obtained, otherwise than through his position as Director, information in respect of which he owes a duty of confidentiality to another person:
- 118.1.1 he shall be under no duty to the Company with respect to that information;
 - 118.1.2 in particular, he shall not be required to disclose that information to the Board or to any Director or any other officer or employee of the Company or to use or apply that information for the purpose of or in connection with the performance of his duties as a Director; and
 - 118.1.3 he shall not be in breach of the general duties he owes to the Company pursuant to sections 171 to 177 of the Companies Act 2006 by virtue of his failure to disclose or use or apply that information as referred to in paragraph 118.1.2 above.
- 118.2 Where the duty of confidentiality referred to in Article 118.1 arises out of or in connection with a Conflict Situation, Article 118.1 shall apply only if the Conflict Situation has been authorised under Article 117.1
- 118.3 Where the matter authorised pursuant to Article 117.1 is a Director's acceptance of or continuance in any office, employment or position in addition to his position as a Director or his relationship with another person and the office, employment, position or relationship authorised gives rise to a conflict of interest or possible conflict of interest, the Director may, for so long as he reasonably believes such conflict of interest or possible conflict of interest subsists:

- 118.3.1 absent himself from any meeting of the Board or of a committee of the Board at which any matter relating to the conflict of interest or possible conflict of interest will or may be discussed or from the discussion of any such matter at a meeting or otherwise; and
- 118.3.2 make arrangements not to receive documents and information relating to any matter relating to the conflict of interest or possible conflict of interest sent or supplied by the Company,

and the Director shall not be in breach of the general duties he owes to the Company pursuant to sections 171 to 177 of the Companies Act 2006 by virtue of his absenting himself from meetings or discussions or making arrangements not to receive documents and information as referred to in paragraphs 118.3.1 and 118.3.2 above.

119 PERMITTED INTERESTS

119.1 Subject to compliance with Article 119.2, a Director, notwithstanding his office:

- 119.1.1 may be a party to or otherwise interested in any transaction or arrangement with the Company or in which the Company is directly or indirectly interested;
- 119.1.2 may hold any other office or place of profit with the Company (except that of auditor) in conjunction with the office of Director for such period and on such terms, including as to remuneration, as the Board may decide;
- 119.1.3 may act by himself or through a firm with which he is associated in a professional capacity for the Company or any body corporate in which the Company is directly or indirectly interested (otherwise than as auditor) on such terms, including as to remuneration, as the Board may decide;
- 119.1.4 may be or become a director or other officer of, or employed by, or a party to any transaction or arrangement with, or otherwise interested (including by the holding of shares or other securities) in, any body corporate promoted by the Company or in which the Company is otherwise directly or indirectly interested or as regards which the Company has any powers of appointment; and
- 119.1.5 may be or become a director of any body corporate in which the Company is not directly or indirectly interested if, at the time of his appointment as a director of that other company, such appointment cannot reasonably be regarded as giving rise to a conflict of interest, and no authorisation under Article 117 shall be required in respect of any such interest.

119.2 If a Director has any interest referred to in Article 119.1, he must declare the nature and extent of that interest to the Board provided always that a Director need not declare an interest:

- 119.2.1 if it cannot reasonably be regarded as likely to give rise to a conflict of interest;
- 119.2.2 if, or to the extent that, the other Directors are already aware of it (and, for this purpose, the other Directors are treated as aware of anything of which they ought reasonably to be aware);
- 119.2.3 of which the Director is not aware or, in the case of an interest in a proposed or existing transaction or arrangement with the Company, where the Director is not aware of the transaction or arrangement in question (and, for this purpose, the

Director is treated as being aware of matters of which he ought reasonably to be aware); or

- 119.2.4 if, or to the extent that, it concerns the terms of his service contract that have been or are to be considered by a meeting of the Board or a committee appointed for the purpose under these Articles.

Any declaration required by this Article 119.2 must be made as soon as is reasonably practicable and, in the case of any interest in a proposed transaction or arrangement with the Company, before the Company enters into the transaction or arrangement. If any such declaration proves to be, or becomes, inaccurate or incomplete, a further declaration must be made.

120 **NO LIABILITY TO ACCOUNT**

A Director shall not, by reason of his office or the fiduciary relationship thereby established, be liable to account to the Company for any remuneration, profit or other benefit which he derives from any transaction or arrangement or from any office, employment, position or relationship or from any interest in any body corporate:

- 120.1.1 the entry into, acceptance, continuance or existence of which has been authorised by the Board pursuant to Article 117 (subject, in any such case, to the terms of such authorisation); or
- 120.1.2 which he is permitted to hold or enter into by virtue of Article 119 or otherwise pursuant to these Articles, nor shall the receipt of any such remuneration, profit or other benefit constitute a breach of his duty under section 176 of the Act. No transaction or arrangement shall be liable to be avoided on the grounds of a Director having an interest therein (including deriving a benefit therefrom) if the interest has been authorised under Article 117 or is permitted under Article 119.

121 **QUORUM AND VOTING REQUIREMENTS**

- 121.1 Save as otherwise provided in these Articles, a Director shall not vote on, or be counted in the quorum in relation to, any resolution of the Board or of a committee concerning any transaction or arrangement in which he has a direct or indirect interest and, if he shall do so, his vote shall not be counted but this prohibition does not apply to any resolution concerning a transaction or arrangement in which his interest cannot reasonably be regarded as likely to give rise to a conflict of interest or to any resolution concerning:

- 121.1.1 the giving of any guarantee, security or indemnity to the Director or any other person in respect of:
- 121.1.1.1 money lent or obligations incurred by him or by any other person at the request of or for the benefit of the Company or any of its subsidiary undertakings; or
 - 121.1.1.2 a debt or other obligation of the Company or any of its subsidiary undertakings for which the Director has assumed responsibility (in whole or in part and whether alone or jointly with others) under a guarantee or indemnity or by the giving of security;
- 121.1.2 an offer by the Company or any of its subsidiary undertakings of securities for subscription, purchase or exchange in which offer the Director is or may be

entitled to participate as a holder of securities or in the underwriting or sub-underwriting of which he is to participate;

- 121.1.3 a transaction or arrangement in which he has an interest only by virtue of an interest or interests in shares, debentures or other securities of the Company or by reason of any other interest in or through the Company;
 - 121.1.4 a transaction or arrangement concerning any other body corporate in which he (or any person connected with him) is interested, directly or indirectly, and whether as an officer, shareholder, creditor, employee or otherwise, if he and any persons connected with him do not to his knowledge hold an interest in shares (within the meaning set out in Part 22 of the Act) representing one per cent or more of either any class of the equity share capital of that body corporate (calculated exclusive of any shares of that class held as treasury shares) or of the voting rights available to members of that body corporate;
 - 121.1.5 a transaction or arrangement concerning the adoption, modification or operation of a pension fund, superannuation or similar scheme or retirement, death or disability benefits scheme or employees' share scheme which relates to both directors and employees of the Company or any of its subsidiary undertakings and does not accord to any Director as such any privilege or benefit not accorded to the employees to whom the fund or scheme relates;
 - 121.1.6 a transaction or arrangement for the benefit of employees of the Company or any of its subsidiary undertakings under which he benefits in a similar manner to the employees and which does not accord to any Director as such any privilege or benefit not accorded to the employees to whom the transaction or arrangement relates;
 - 121.1.7 any proposal relating to the purchase or maintenance of insurance against any liability for the benefit of any Director or Directors or for the benefit of persons who include Directors;
 - 121.1.8 the giving of indemnities in favour of Directors; and
 - 121.1.9 the funding of expenditure incurred or to be incurred by any Director or Directors in defending any criminal or civil proceedings or in connection with an application to the court for relief or in defending him or them in any investigation by, or against action proposed to be taken by, a regulatory authority or the doing of anything to enable any Director or Directors to avoid incurring any such expenditure.
- 121.2 A Director shall not vote on, or be counted in the quorum in relation to, any resolution of the Board or of a committee concerning his own appointment (including the settlement or variation of the terms of his appointment or its termination) as the holder of any office or place of profit with the Company or any company in which the Company is interested. Where proposals are under consideration concerning the appointment (including the settlement or variation of the terms of appointment or its termination) of two or more Directors to offices or places of profit with the Company or any company in which the Company is interested, such proposals may be divided and considered in relation to each Director separately. In such a case, each of the Directors concerned (if not otherwise debarred from voting under these Articles shall be entitled to vote (and be counted in the quorum) in respect of each resolution except that concerning his own appointment.
- 121.3 If any question arises at a meeting of the Board or of a committee as to whether the interest of any Director (other than the chairman of the meeting) may reasonably be regarded as

likely to give rise to a conflict of interest or as to the entitlement of any Director (other than the chairman of the meeting) to vote or be counted in the quorum and the question is not resolved by his voluntarily agreeing to abstain from voting or not to be counted in the quorum, the question shall be referred to the chairman of the meeting. The ruling of the chairman of the meeting in relation to the Director concerned shall be final and conclusive except in a case where the nature or extent of the interest of the Director concerned (so far as is known to him) has not been fairly disclosed. If any such question shall arise in relation to the chairman of the meeting, the question shall be decided by a resolution of the Directors or members of the committee present at the meeting (excluding the chairman). The majority vote of such Directors or committee members shall be final and conclusive except in a case where the nature or extent of the interest of the chairman of the meeting (so far as is known to him) has not been fairly disclosed.

122 **GENERAL**

122.1 The Company may by ordinary resolution:

122.1.1 suspend or relax any provision of Articles 117 to 121 to any extent, either generally or in respect of any particular matter; and

122.1.2 ratify any transaction, arrangement or other matter not properly authorised by reason of a contravention of any provision of these Articles.

122.2 For the purposes of Articles 117 to 121:

122.2.1 a conflict of interest includes a conflict of interest and duty and a conflict of duties;

122.2.2 references to an interest of a Director shall be construed so as to include the interest of a person who is connected with the Director (and, for this purpose, section 252 of the Act shall determine whether a person is connected with a Director);

122.2.3 in relation to an alternate Director, the interest of his appointor shall be treated as the interest of the alternate Director in addition to any interest which the alternate Director otherwise has; and

122.2.4 Articles 117 to 121 apply to an alternate Director as if he were a director of the Company appointed as such.

SECRETARY

123 **SECRETARY**

123.1 Subject to the provisions of the Companies Acts, the Board shall appoint a secretary or joint secretaries of the Company and shall have power to appoint one or more persons to be an assistant or deputy secretary. Any such appointment shall be at such remuneration and on such terms and conditions as the Board thinks fit. Any person so appointed may be removed by the Board at any time but any such removal shall be without prejudice to any claim for damages for breach of any contract of service between the person concerned and the Company.

123.2 If the office of secretary is vacant or if for any reason the secretary is incapable of acting, anything required or authorised by the Companies Acts or these Articles to be done by or to the secretary may be done by or to any assistant or deputy secretary or, if there is no

assistant or deputy secretary, by any officer of the Company authorised either generally or specifically by the Board in that regard.

- 123.3 Any provision of the Companies Acts or of these Articles requiring or authorising a thing to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as Director and as, or in the place of, the Secretary.

THE SEAL

124 CUSTODY AND USE OF THE SEAL

- 124.1 The Board shall provide for the safe custody of every Seal. A Seal shall only be used with the authority of the Board or of a committee authorised by the Board in that behalf.
- 124.2 The Board may decide whether any instrument to which the common seal of the Company is affixed shall be signed and, if it is to be signed, who shall sign it and by what means. The Board may also decide, either generally or in a particular case, that a signature may be dispensed with or applied by mechanical, electronic or other means.
- 124.3 Unless the Board otherwise decides:
- 124.3.1 share certificates and, subject to the provisions of any instrument constituting the same, certificates in respect of any debentures or other securities which are issued under the common seal of the Company need not be signed; and
 - 124.3.2 every other instrument to which the common seal of the Company is affixed shall be signed by one Director and the Secretary or by two Directors or by one Director in the presence of a witness who attests the signature or by such other person or persons as the Board or a committee shall authorise for that purpose.
- 124.4 Unless the Board otherwise decides or the Companies Acts otherwise require, any instrument to which any official seal of the Company is applied need not be signed by any person.

125 EXECUTION OF INSTRUMENTS HAVING THE SAME EFFECT AS IF EXECUTED UNDER SEAL ANY INSTRUMENT SIGNED:

- 125.1.1 by one Director and the Secretary; or
- 125.1.2 by two Directors; or
- 125.1.3 by one Director in the presence of a witness who attests the signature, and expressed (in whatever form of words) to be executed by the Company shall have the same effect as if executed under the common seal of the Company.

AUTHENTICATION OF DOCUMENTS AND MINUTES

126 AUTHENTICATION OF DOCUMENTS

- 126.1 Any Director or the Secretary or any other person appointed by the Board for the purpose shall have power to authenticate:
- 126.1.1 any documents comprising or affecting the constitution of the Company;
 - 126.1.2 any resolutions passed by the Company or the Board or a committee; and

- 126.1.3 any books, records, documents or accounts relating to the business of the Company, and to certify copies of them or extracts from them as true copies of or extracts.

A document purporting to be a copy of a resolution of, or the minutes (or an extract from the minutes) of a meeting of, the Company or the Board or a committee which is so certified shall be conclusive evidence in favour of all persons dealing with the Company that the resolution was duly passed or that the minutes are (or the extract from the minutes is) a true and accurate record of proceedings at a duly constituted meeting.

- 126.2 Where any books, records, documents or accounts are elsewhere than at the Office, the local manager or other officer of the Company who has their custody shall be deemed to be a person appointed by the Board for this purpose.

127 **MINUTES AND BOOKS**

- 127.1 The Board shall cause minutes to be made of:

127.1.1 all appointments of officers made by the Board;

127.1.2 all appointments of committees;

127.1.3 the names of the Directors (including any alternate Directors) present at each meeting of the Company, of the Board and of any committee; and

127.1.4 all resolutions and proceedings of all meetings of the Company, of the Board and of any committee.

- 127.2 Any such minutes, if purporting to be signed by the chairman of the meeting at which the proceedings took place or by the chairman of the next following meeting or by the Secretary, shall be sufficient evidence, without any further proof, of the matters stated in such minutes.

DIVIDENDS

128 **DECLARATION OF DIVIDENDS**

- 128.1 Subject to the provisions of the Companies Acts and of these Articles, the Company may by ordinary resolution declare dividends to be paid to members according to their respective rights and interests in the profits of the Company. However, no dividend shall exceed the amount recommended by the Board nor be available for distribution at any earlier date than the date recommended by the Board.

129 **FIXED AND INTERIM DIVIDENDS**

- 129.1 Subject to the provisions of the Companies Acts, if and so far as in the opinion of the Board the profits of the Company available for distribution justify such payments, the Board may declare and pay:

129.1.1 fixed dividends on any class of shares carrying a fixed dividend on the dates prescribed for the payment of those dividends; and

129.1.2 interim dividends on shares of any class of such amounts and on such dates and in respect of such periods as the Board thinks fit.

- 129.2 If at any time the share capital of the Company is divided into different classes, the Board may pay interim dividends on shares which rank after shares conferring preferred rights with

regard to dividend as well as on shares conferring preferred rights, unless at the time of payment any preferential dividend is in arrear.

- 129.3 If the Board acts in good faith, none of the Directors shall incur any liability to the holders of any shares conferring preferred rights for any loss they may suffer by the lawful payment of any interim dividend on any shares having rights ranking after those with preferred rights.

130 **DIVIDEND IN SPECIE**

- 130.1 A general meeting declaring a dividend may, on the recommendation of the Board, by ordinary resolution direct that all or any part of the dividend shall be satisfied by the distribution of assets (including without limitation paid up shares or debentures of another body corporate).

- 130.2 The Board may make any, arrangements it thinks fit to settle any difficulty arising in connection with the distribution and, in particular may:

130.2.1 ignore fractions or issue certificates for fractions or authorise any person to sell and transfer fractions;

130.2.2 fix the value for distribution of any assets;

130.2.3 determine that cash payments may be made to any members on the basis of the value so fixed in order to adjust the rights of members; and

130.2.4 vest any assets in trustees on trust for the persons entitled to the dividend.

131 **CALCULATION AND CURRENCY OF DIVIDENDS**

- 131.1 Except insofar as the rights attaching to, or the terms of issue of, any shares otherwise provide:

131.1.1 all dividends shall be declared and paid according to the amounts paid up on the shares in respect of which the dividend is declared and paid; and

131.1.2 all dividends shall be apportioned and paid proportionately to the amount paid up on the shares during any portion or portions of the period in respect of which the dividend is paid.

For the purpose of this Article 131.1, no amount paid up on a share in advance of the date on which a call is payable shall be treated as paid up on the share.

- 131.2 Subject to the provisions of these Articles and to the rights attaching to any shares, any dividend or any other moneys payable in respect of a share may be declared or paid in whatever currency the Board may decide.

- 131.3 If a dividend is to be paid in a currency other than the currency in which it was declared, the exchange rate to be used for conversion of the dividend shall be such rate at such time on such date as the Board may decide.

132 **NO INTEREST ON DIVIDENDS**

Unless otherwise provided by the rights attaching to the share, no dividend or other moneys payable on or in respect of a share shall bear interest as against the Company.

133 **PERMITTED DEDUCTIONS AND RETENTIONS**

133.1 The Board may:

133.1.1 deduct from any dividend or other moneys payable to any person on or in respect of any share all such sums as may be due from him to the Company on account of calls or otherwise in relation to shares of the Company; and

133.1.2 apply any moneys so deducted in or towards satisfaction of the amounts owed to the Company in relation to such shares.

133.2 Where a person is entitled by transmission to a share, the Board may withhold payment of any dividend payable in respect of that share until such person (or the person to whom such person transfers the same) becomes the holder of that share.

134 **MANNER OF PAYMENT OF DIVIDENDS**

134.1 The Company may pay any dividend or other moneys payable in respect of a share:

134.1.1 in cash; or

134.1.2 by cheque, warrant or money order made payable to or to the order of the person entitled to payment; or

134.1.3 by any bank or other funds transfer system to an account designated by notice in writing to the Company by the person entitled to payment; or

134.1.4 in respect of a share in uncertificated form, by means of the Relevant System (subject to the facilities and requirements of the Relevant System); or

134.1.5 by any other method as may be approved by the Board and agreed (in such form as the Company thinks appropriate) by the person entitled to payment.

134.2 A cheque, warrant or money order may be sent by post:

134.2.1 in the case of a sole holder, to his registered address; or

134.2.2 in the case of joint holders, to the registered address of the person whose name appears first in the Register; or

134.2.3 in the case of a person or persons entitled by transmission to a share, as if it were a notice to be sent under Article 148; or

134.2.4 in any case, to such person and to such address as the person entitled to payment may direct by notice to the Company.

134.3 If two or more persons are registered as joint holders of any share or are entitled by transmission jointly to a share:

134.3.1 the Company may pay any dividend or other moneys payable in respect of the share to any one of them and any one of them may give an effective receipt for that payment; and

134.3.2 for the purpose of this Article 134, the Company may rely in relation to the share on the written direction, designation or agreement of, or notice to the Company by, any one of them.

135 DISCHARGE TO THE COMPANY AND RISK

- 135.1 Payment of a cheque, warrant or money order or the collection of funds from or transfer of funds by a bank or other funds transfer system or, in respect of shares in uncertificated form, the making of payment in accordance with the facilities and requirements of the Relevant System (which may include the sending by the Company or by any person on its behalf of an instruction to the Operator of the Relevant System to credit the cash memorandum account of the holder or joint holders or, if permitted by the Company, of such person as the holder or joint holders may direct in writing) shall be a good discharge to the Company.
- 135.2 Every cheque, warrant or money order sent in accordance with these Articles is sent at the risk of the person entitled to payment. The Company shall have no responsibility for any sum lost or delayed in the course of transfer by or through any bank or other funds transfer system (including a Relevant System) or where it has acted on any directions given in writing by the person entitled to payment.

136 UNCASHED DIVIDENDS

If:

- 136.1.1 cheques, warrants or money orders for dividends or other moneys payable in respect of a share sent by the Company to the person entitled thereto are returned to the Company or left uncashed on two consecutive occasions; or
- 136.1.2 following one such occasion, reasonable enquiries have failed to establish any new address to be used for the purpose,

the Company shall not be obliged to send any dividends or other moneys payable in respect of that share due to that person until he notifies the Company of an address to be used for the purpose.

137 UNCLAIMED DIVIDENDS

- 137.1 Any unclaimed dividend or other amount payable on or in respect of a share may be invested or otherwise made use of by the Board for the benefit of the Company until claimed.
- 137.2 The payment of any unclaimed dividend or other amount payable on or in respect of a share into a separate account shall not constitute the Company a trustee in respect of it and the Company shall not be liable to pay interest in respect of it.
- 137.3 Any dividend which has remained unclaimed for a period of **12** years after it was declared or became due for payment shall, if the Board so resolves, be forfeited and shall cease to remain owing by the Company.

138 WAIVER OF DIVIDENDS

The waiver, in whole or in part, of any dividend on any share shall be effective only if such waiver is in writing (whether or not executed as a deed) signed by the holder (or the person entitled by transmission to the share) and delivered to the Company and if, or to the extent that, the same is accepted as such or acted upon by the Company.

139 SCRIP DIVIDENDS

- 139.1 Subject as provided in this Article 139, the Board may, with the prior authority of an ordinary resolution of the Company and subject to such terms and conditions as the Board may

decide, offer holders of ordinary shares (excluding any ordinary shares held as treasury shares) the right to elect to receive new ordinary shares, credited as fully paid, instead of all or part of any dividend specified by the ordinary resolution (rights of election). The ordinary resolution may specify a particular dividend or dividends (whether declared or not) or may specify all or any dividends declared or paid within a specified period but such period may not end later than the fifth anniversary of the date of the meeting at which the resolution is passed.

139.2 The Board may offer rights of election:

139.2.1 in respect of the next dividend proposed to be paid; or

139.2.2 in respect all future dividends (in respect of which a scrip dividend alternative is made available) until such time as the election is revoked,

or may allow holders of ordinary shares to make an election in either form.

139.3 If and whenever the Board decides to offer rights of election, the following provisions shall apply:

139.3.1 the entitlement of each holder of ordinary shares to new ordinary shares shall be such that the relevant value of the entitlement is as nearly as possible equal to (but not greater than) the cash amount (disregarding any tax credit) of the dividend that such holder would have received by way of dividend. For this purpose, **relevant value** shall be calculated by reference to the average of the middle market quotations for the ordinary shares on the London Stock Exchange, as derived from the AIM segment of the Daily Official List, for the day on which the ordinary shares are first quoted "ex" the relevant dividend and the four subsequent dealing days or in such other manner as may be determined by or in accordance with the ordinary resolution. A certificate or report by the Auditors as to the amount of the relevant value in respect of any dividend shall be conclusive evidence of that amount;

139.3.2 no fraction of a share shall be allotted and the Board may make such provision as it thinks fit for any fractional entitlements including provision whereby, in whole or in part, the benefit of fractional entitlements accrues to the Company and/or provision under which fractional entitlements are accrued and/or retained and in each case accumulated on behalf of any holder of ordinary shares and such accruals or retentions are applied to the allotment by way of bonus to or cash subscription on behalf of such member of fully paid ordinary shares and/or provision whereby cash payments are made to such holders in respect of their fractional entitlements;

139.3.3 the Board shall notify holders of ordinary shares in writing of the right of election offered to them and of the procedure to be followed (including details of the place at which, and the latest time by which, duly completed forms of election must be lodged) in order for elections to be effective save that no such notification need be given to a holder of ordinary shares who has previously made, and has not revoked, an earlier election to receive ordinary shares in lieu of all future dividends and the Board shall instead send him a reminder that he has made such an election, indicating how that election may be revoked in time for the next dividend proposed to be paid;

139.3.4 the dividend (or that part of the dividend in respect of which a right of election has been offered) shall not be payable in cash on ordinary shares in respect of which

an election has been duly made (**elected shares**) and instead additional ordinary shares shall be allotted to the holders of elected shares on the basis of allotment determined as stated above. For this purpose, the Board shall capitalise, out of any amount for the time being standing to the credit of any reserve or fund (including any share premium account or capital redemption reserve) or any of the profits which could otherwise have been applied in paying dividends in cash as the Board may decide, a sum equal to the aggregate nominal amount of the additional ordinary shares to be allotted on such basis and shall apply it in paying up in full the appropriate number of new ordinary shares for allotment and distribution to the holders of the elected shares on such basis. A resolution of the Board capitalising any part of any reserve or profits as is mentioned in this Article 139.3.4 shall have the same effect as if such capitalisation had been declared by ordinary resolution of the Company and, in relation to any such capitalisation, the Board may exercise all the powers conferred on it by these Articles without need of such ordinary resolution;

- 139.3.5 the additional ordinary shares so allotted shall rank pari passu in all respects with the fully paid ordinary shares in issue on the record date for the dividend in respect of which the right of election has been offered, except that they will not rank for any dividend or other distribution or entitlement declared, made or paid by reference to such record date;
- 139.3.6 unless the Board otherwise decides or the uncertificated securities rules otherwise require, the additional ordinary shares so allotted shall, if the corresponding elected shares were in uncertificated form, be uncertificated shares and, if the corresponding elected shares were in certificated form, be certificated shares;
- 139.3.7 the Board may, in its absolute discretion, decide that rights of election shall not be made available to holders of ordinary shares with registered addresses in any territory where it considers that:
 - 139.3.7.1 this is necessary or desirable to deal with any legal or practical problems under the laws of, or the requirements of any recognised regulatory body or stock exchange in, that territory; or
 - 139.3.7.2 special formalities would otherwise apply in connection with the circulation of an offer of rights of election in that territory; or
 - 139.3.7.3 it would be impractical or unduly onerous to make available rights of election to any holder of ordinary shares with a registered address in that territory,

and, in such event, the provisions of this Article 139 shall be read and construed subject to such determination; and

- 139.3.8 the Board may in its absolute discretion terminate or withdraw any offer previously made to holders of Equity Shares to elect to receive additional Equity Shares in lieu of a dividend (or part of it) and, in such event, the dividend shall be paid in cash as if no elections had been made in respect of it. Any such termination or withdrawal may be made at any time prior to the allotment of additional Equity Shares in lieu of such dividend, whether before or after the exercise of rights of election.

RESERVES

140 ESTABLISHMENT OF RESERVES

- 140.1 The Board may from time to time set aside out of the profits of the Company and carry to reserve such sums as it thinks fit. All sums standing to reserve may, at the discretion of the Board, be applied for any purpose to which the profits of the Company may properly be applied and, pending such application, may, at the discretion of the Board, either be employed in the business of the Company or be invested in such investments as the Board thinks fit. The Board may divide the reserve into such special funds as it thinks fit and may consolidate into one fund any special funds or any parts of any special funds into which the reserve may have been divided as it thinks fit.
- 140.2 The Board may also, without placing the same to reserve, carry forward any profits.

CAPITALISATION OF PROFITS

141 CAPITALISATION ISSUE

The Board may, with the authority of an ordinary resolution of the Company:

- 141.1.1 resolve to capitalise any undistributed profits of the Company not required for paying any preferential dividend (whether or not they are available for distribution) or any sum standing to the credit of any reserve account of the Company (including any share premium account, capital redemption, reserve or other undistributable reserve);
- 141.1.2 appropriate the sum resolved to be capitalised to the members or any class of members on the record date specified in, or determined in accordance with, the relevant resolution who would have been entitled to it if it were distributed by way of dividend and in the same proportions; and
- 141.1.3 apply that sum on their behalf either in or towards paying up the amounts (if any) for the time being unpaid on any shares held by them respectively or in paying up in full unissued shares or debentures of the Company of a nominal amount equal to that sum (in which case, for the purposes of this Article, the restrictions under the Companies Acts on the payment of dividends and the making of distributions in respect of shares held as treasury shares shall be deemed not to apply), and allot the shares or debentures credited as fully paid, to those members, or as they may direct, in those proportions, or partly in one way and partly in the other, or otherwise deal with such sum as directed by the relevant resolution, provided that the share premium account, the capital redemption reserve, any other undistributable reserve and any profits which are not available for distribution may only be applied in paying up unissued shares to be allotted credited as fully paid.
- 141.2 The Board may do all acts and things it considers necessary or expedient to give effect to any such capitalisation. Where any difficulty arises in respect of any distribution of any capitalised reserve or other sum, the Board may settle the difficulty as it thinks fit. In particular, the Board may make such provision as it thinks fit in the case of any shares or debentures which become, or would otherwise become, distributable in fractions (including provisions whereby fractional entitlements are disregarded or under which the benefit of fractional entitlements accrues to the Company rather than to the members concerned).
- 141.3 The Board may also authorise any person to sign on behalf of all the members concerned an agreement with the Company providing for any such capitalisation and matters incidental

thereto and any agreement made under that authority shall be effective and binding on all concerned.

RECORD DATES

142 FIXING OF RECORD DATES

- 142.1 Notwithstanding any other provision of these Articles but without prejudice to the rights attached to any shares and subject always to the Companies Acts, the Company or the Board may fix any time on any date as the record date by reference to which a dividend is to be declared or a distribution, allotment or issue is to be made. Such record date may be on or at any time before or after any date on which the dividend, distribution, allotment or issue is declared, paid or made.
- 142.2 In the absence of a record date being fixed, entitlement to any dividend, distribution, allotment or issue shall be determined by reference to the date on which the dividend is declared or the distribution, allotment or issue is made.

ACCOUNTS AND AUDITORS

143 INSPECTION OF RECORDS

- 143.1 No member (other than a member who is also a Director or other officer of the Company) shall have any right to inspect any accounting records or any other books, documents or papers of the Company unless:
- 143.1.1 he is entitled to do so pursuant to the Companies Acts or an order of a court of competent jurisdiction; or
- 143.1.2 he is authorised to do so by the Board or by ordinary resolution of the Company.

144 ANNUAL ACCOUNTS AND SUMMARY FINANCIAL STATEMENTS

- 144.1 A copy of every balance sheet and profit and loss account (including every document required by law to be annexed thereto) which is to be laid before a general meeting of the Company and of the Directors' and Auditors' reports shall, not less than 21 clear days before the date of the meeting, be sent or supplied:
- 144.1.1 to every member;
- 144.1.2 to every debenture holder of the Company; and
- 144.1.3 to every other person who is entitled to receive notices of general meetings from the Company under the provisions of the Companies Acts or these Articles, provided that this Article 144.1 shall not require a copy of these documents to be sent or supplied to more than one of the joint holders of any shares or debentures or to any person of whose address the Company is unaware but any member or debenture holder to whom a copy of these documents has not been sent shall be entitled to receive a copy free of charge on application at the Office.
- 144.2 The requirements of Article 144.1 shall be deemed satisfied in relation to any person by sending to the person, where permitted by the Companies Acts and instead of such copies, a summary financial statement derived from the Company's annual accounts and the Directors' report and prepared in the form and containing the information prescribed by the Companies Acts and any regulations made under them.

145 VALIDITY OF AUDITORS' ACTS

- 145.1 Auditors shall be appointed and their duties, powers, rights and remuneration regulated in accordance with the provisions of the Statutes.
- 145.2 Subject to the provisions of the Companies Acts, all acts done by the Auditors acting as the auditors of the Company shall, as regards all persons dealing in good faith with the Company, be valid notwithstanding that there was some defect in their appointment or that, at the time of appointment, they were not qualified for appointment or subsequently became disqualified.
- 145.3 The Auditors shall be entitled to attend any general meeting and to receive all notices of and other communications relating to any general meeting which any member is entitled to receive, and to be heard at any general meeting on any part of the business of the meeting which concerns them as Auditors.

NOTICES

146 NOTICES TO BE IN WRITING

Any notice to be given to or by any person pursuant to these Articles (other than a notice convening a meeting of the Board or of a committee) shall be in writing.

147 METHOD OF GIVING NOTICE TO MEMBERS

- 147.1 Any notice, document or information may be served on or sent or supplied to any member by the Company:
 - 147.1.1 personally; or
 - 147.1.2 by sending it through the post in a pre-paid envelope addressed to the member at his registered address (or at a postal address in the United Kingdom notified for the purpose); or
 - 147.1.3 by delivering it by hand to or leaving it at that address in an envelope addressed to the member; or
 - 147.1.4 by sending it by electronic means to an address notified by the member to the Company for that purpose; or
 - 147.1.5 by making it available on a website and notifying the member of its availability in accordance with this Article 147.1; or
 - 147.1.6 by means of a Relevant System; or
 - 147.1.7 by any other means authorised in writing by the member concerned.
- 147.2 In the case of joint holders of a share:
 - 147.2.1 all notices, documents or information shall be served on or sent or supplied to the joint holder whose name stands first in the Register in respect of the joint holding and any notice, document or information so served, sent or supplied shall be deemed for all purposes served on or sent or supplied to all the joint holders; and
 - 147.2.2 anything to be agreed or specified in relation to any notice, document or information to be served on or sent or supplied to them may be agreed or specified by the joint holder whose name stands first in the register in respect of the joint

holding and any such agreement or specification shall be deemed for all purposes to be agreed or specified by all the joint holders. The agreement or specification of the senior joint holder shall be accepted to the exclusion of that of any of the other joint holders and, for this purpose, seniority shall be determined by the order in which the names of the stand in the Register in respect of the joint holding.

- 147.3 Where a member (or, in the case of a joint holders, the person first named in the Register) has a registered address outside the United Kingdom but has notified the Company of an address within the United Kingdom at which notices, documents or other information may be given to him or her or has given to the Company an address for the purposes of communications by electronic means at which notices, documents or other information may be served, sent or supplied to him or her, the member shall be entitled to have notices served, sent or supplied to him or her at such address or, where applicable, the Company may make them available on a website and notify the holder of that address. Otherwise no such member shall be entitled to receive any notice, document or other information from the Company.
- 147.4 The Board may from time to time issue, endorse or adopt terms and conditions relating to the use of electronic means for the sending of notices, other documents and proxy appointments by the Company to members or persons entitled by transmission and by members or persons entitled by transmission to the Company.
- 147.5 If on three consecutive occasions any notice, document or information served on or sent or supplied to a member has been returned undelivered, such member shall not thereafter be entitled to receive any notices, documents or information from the Company until he has communicated with the Company and supplied to the Company:
- 147.5.1 a new registered address within the United Kingdom or a postal address within the United Kingdom for the service, sending or supply of notices, documents and information; or
 - 147.5.2 an address for the service, sending or supply of notices, documents and information by electronic means.

For these purposes, any notice, document or information sent by post shall be treated as returned undelivered if the notice, document or information is sent back to the Company (or its agents) and any notice, document or information sent by electronic means shall be treated as returned undelivered if the Company (or its agents) receives notification that the notice, document or information was not delivered to the address to which it was sent.

- 147.6 The Board may at any time and in its absolute discretion decide that:
- 147.6.1 notices, documents or information should be served on or sent or supplied to some or all members in hard copy form alone; and
 - 147.6.2 a notice, document or information should not be served on or sent or supplied to a particular member or members if it considers that such service, sending or supply would or might infringe the laws of any jurisdiction or give rise to legal, regulatory or practical problems in, or under the laws of, any territory.

148 **NOTICE TO PERSONS ENTITLED BY TRANSMISSION**

- 148.1 A person entitled by transmission to a share, upon supplying to the Company:
- 148.1.1 a postal address within the United Kingdom for the service, sending or supply of notices, documents and information; or

- 148.1.2 an address for the service, sending or supply of notices, documents and information by electronic means, shall be entitled to have served on him or sent or supplied to him at that address any notice, document or information to which he would have been entitled if he were the holder of that share or, where applicable, to be notified at that address of the availability of the notice, document or information on a website. Such service, sending or supply shall for all purposes be deemed a sufficient service on all persons interested (whether jointly with or as claimants though or under him) in the share.
- 148.2 Otherwise, any notice, document or information served on or sent or supplied to any member pursuant to these Articles shall, notwithstanding that the member is then dead or bankrupt or that any other event giving rise to the transmission of the share by operation of law has occurred and whether or not the Company has notice of the death, bankruptcy or other event, be deemed to have been properly served, sent or supplied in respect of any share registered in the name of that member as sole or joint holder.
- 148.3 The Board may at any time and in its absolute discretion decide that:
- 148.3.1 notices, documents or information should be served on or sent or supplied to some or all persons entitled by transmission in hard copy form alone; and
- 148.3.2 a notice, document or information should not be served on or sent or supplied to a particular person or persons entitled by transmission if it considers that such service, sending or supply would or might infringe the laws of any jurisdiction or give rise to legal, regulatory or practical problems in, or under the laws of, any territory.

149 **RECORD DATE FOR SERVICE**

- 149.1 Any notice, document or other information may be served, sent or supplied by the Company by reference to the Register as it stands at any time not more than 15 days before the date of service, sending or supply. No change to any entry on the Register after that time shall invalidate that service, sending or supply.
- 149.2 Where any notice, document or other information is served on, sent or supplied to any person in respect of a share in accordance with these Articles, no person deriving any title or interest in that share shall be entitled to any further service, sending or supplying of that notice, document or other information.

150 **EVIDENCE OF SERVICE**

- 150.1 Any notice, document or information served, sent or supplied by the Company shall be deemed to have been received by the intended recipient:
- 150.1.1 if properly addressed, served, sent or supplied by post:
- 150.1.1.1 (where first class post is employed) on the day after the day on which it was posted; and
- 150.1.1.2 (where second class post is employed) on the second day after the day on which it was posted;
- 150.1.1.3 if sent by airmail from an address in the United Kingdom to an address outside the United Kingdom, or from an address in another country to an address outside that country (including without limitation an

address in the United Kingdom) on the third day following that on which the document or information was posted; and

in proving such receipt, it shall be sufficient to prove that an envelope containing the notice, document or information was properly addressed, prepaid and put into the post;

- 150.1.2 if not served, sent or supplied by post but delivered by hand to or left at a registered address or an address for service in the United Kingdom, on the day on which it was so delivered or left;
- 150.1.3 if served, sent or supplied by means of a Relevant System, when the Company or any sponsoring system-participant acting on its behalf sent the issuer-instruction relating to the notice, document or information;
- 150.1.4 if served, sent or supplied by electronic means, on the day on which it was sent even if the Company subsequently sends such notice, document or information in hard copy form by post and, in proving such receipt, it shall be sufficient to show that the notice, document or information was properly addressed;
- 150.1.5 if served, sent or supplied by being made available on a website, be deemed to have been received on the day on which the notice, document or information was first made available on the website or, if later, when notification of the availability of the notice, document or information on the website was received or is deemed to have been received in accordance with this Article 150.1; and
- 150.1.6 if served, sent or supplied by any other means authorised in writing by a member, when the Company has carried out the action it has been authorised to take for that purpose.

150.2 A member present in person or by proxy at any meeting of the Company shall be deemed to have been received due notice of the meeting and, where requisite, of the purposes for which the meeting was called.

151 NOTICE DURING DISRUPTION OF SERVICES

If at any time there is a suspension, interruption or curtailment of postal services within the United Kingdom or a part of the United Kingdom, the Company need only give notice of a general meeting to those members with whom the Company can communicate by electronic means and who have provided the Company with an address for this purpose. The Company shall also advertise the notice in at least one national newspaper and make the notice available on its website from the date of such advertisement until the conclusion of the meeting or any adjournment thereof. If advertised in more than one newspaper, the advertisements shall appear on the same date. Such notice shall be deemed to have been sent to all persons who are entitled to have notice of meetings sent to them on the day when the advertisement appears. If, at least seven days prior to the meeting the sending of notices by post in hard copy form to addresses throughout the United Kingdom again becomes practicable, the Company shall send confirmatory copies of the notice by post to those members to whom the Company would otherwise have sent the original notice in hard copy form by post.

DESTRUCTION OF DOCUMENTS

152 DESTRUCTION OF DOCUMENTS

- 152.1 Subject to compliance with the uncertificated securities rules in relation to shares held in uncertificated form, the Company may destroy:
- 152.1.1 any instrument of transfer of shares which has been registered, at any time after a period of six years has elapsed from the date of registration;
 - 152.1.2 any other document on the basis of which an entry is made in the Register, at any time after a period of six years has elapsed from the date on which the entry was first made in the Register in respect of it;
 - 152.1.3 any share certificate which has been cancelled, at any time after a period of one year has elapsed from the date of cancellation;
 - 152.1.4 any instruction concerning the payment of dividends or other moneys in respect of any share or any notification of change of name or address, at any time after a period of two years has elapsed from the date on which the instruction or notification was recorded by the Company;
 - 152.1.5 any proxy appointment which has been used for the purposes of a poll, at any time after a period of one year has elapsed from the date of use;
 - 152.1.6 any proxy appointment which has not been used for the purpose of a poll, at any time after a period of one month has elapsed from the end of the meeting to which the proxy appointment relates; and
 - 152.1.7 any share warrant (or coupon or token relating to a share warrant) which has been surrendered to the Company, at any time after a period of seven years has elapsed from the date of surrender, provided always that the Company may destroy any such document before the expiration of the applicable period if a copy of such document is made (whether electronically, by microfilm, by digital imaging or by any other means) and retained until the expiration of the applicable period.
- 152.2 It shall conclusively be presumed in favour of the Company that:
- 152.2.1 every entry in the Register purporting to have been made on the basis of an instrument of transfer or other document so destroyed was duly and properly made;
 - 152.2.2 every instrument of transfer so destroyed was a valid and effective instrument duly and properly registered;
 - 152.2.3 every share certificate so destroyed was a valid and effective certificate duly and properly cancelled; and
 - 152.2.4 every other document so destroyed was a valid and effective document in accordance with its recorded particulars in the books or records of the Company.
- 152.3 This Article 152 shall apply only to the destruction of a document in good faith and without notice of any claim (regardless of the parties thereto) to which the document might be relevant.

152.4 Nothing in this Article 152 shall be construed as imposing on the Company any liability in respect of the destruction of any document otherwise than as provided for in this Article 152 or in any other circumstances which would not attach to the Company in the absence of this Article 152.

152.5 In this Article 152:

152.5.1 references to the destruction of any document include references to its disposal in any manner; and

152.5.2 references to an instrument of transfer include, in relation to any uncertificated shares, any instruction or notification made in accordance with the Relevant System relating to the transfer of such shares.

WINDING UP

153 BOARD'S POWER TO PETITION

The Board shall have power in the name and on behalf of the Company to present a petition to the court for the Company to be wound up.

154 DISTRIBUTION OF ASSETS IN SPECIE

If the Company is wound up (whether the liquidation is voluntary, under supervision of the court or by the court), the liquidator may, with the authority of a special resolution and any other sanction required by the Companies Acts, divide among the members in specie the whole or any part of the assets of the Company (whether or not the assets consist of property of one kind or different kinds). For this purpose, the liquidator may set such value as he considers fair on any one or more class or classes of property and may, subject to any special rights attached to any shares or the terms of issue thereof, determine how such division shall be carried out as between the members or classes of members. The liquidator may, with the same authority, transfer the whole or any part of the assets to trustees on such trusts for the benefit of members as the liquidator with the same authority thinks fit. The liquidation may then be closed and the Company dissolved. However, the liquidator shall not, except with the consent of the member concerned, distribute to a member any asset to which there is attached a liability or potential liability for the owner.

DIRECTORS' LIABILITIES

155 INDEMNITY

So far as may be permitted by the Companies Acts but without prejudice to any indemnity to which he may otherwise be entitled, every director or former director of the Company or of an Associated Company shall be indemnified by the Company out of its own assets against:

155.1.1 any liability incurred by or attaching to him in connection with any negligence, default, breach of duty or breach of trust by him in relation to the Company or an Associated Company; and

155.1.2 any other liability incurred by or attaching to him in the actual or purported execution or discharge of his duties or in the actual or purported exercise of his powers and discretions or otherwise in relation to or in connection with his duties, powers or offices in relation to the Company or an Associated Company, provided always that this Article does not authorise any indemnity which would be

prohibited or rendered void by any provision of the Companies Acts or by any other provision of law.

155.2 So far as may be permitted by the Companies Acts but without prejudice to any indemnity to which he may otherwise be entitled, every director or former director of the Company or of an Associated Company shall be indemnified by the Company out of its own assets against any liability incurred by him in connection with the activities of the Company or an Associated Company in its capacity as a trustee of an occupational pension scheme (as defined in section 235(6) of the Act) provided always that this Article 155.3 does not authorise any indemnity which would be prohibited or rendered void by any provision of the Companies Acts or by any other provision of law.

155.3 So far as may be permitted by the Companies Acts, the Company may:

155.3.1 provide a director or former director of the Company or of an Associated Company with funds to meet expenditure incurred or to be incurred by him in defending any criminal or civil proceedings in connection with any alleged negligence, default, breach of duty or breach of trust by him in relation to the Company or an Associated Company or in connection with an application for relief under the provisions referred to in section 205(5) of the Act; and

155.3.2 do anything to enable him to avoid incurring such expenditure, provided always that any loan made or liability incurred under any transaction connected with anything done pursuant to this Article 155.4 shall be repaid or (as the case may be) discharged in accordance with section 205(2) of the Act.

155.4 So far as may be permitted by the Companies Acts, the Company may:

155.4.1 provide a director or former director of the Company or of an Associated Company with funds to meet expenditure incurred or to be incurred by him in defending himself in an investigation by a regulatory authority or against action proposed to be taken by a regulatory authority in connection with any alleged negligence, default, breach of duty or breach of trust by him in relation to the Company or an Associated Company; and

155.4.2 do anything to enable him to avoid incurring such expenditure.

156 **INSURANCE**

Without prejudice to Article 155 and to the extent permitted by the Companies Acts, the Board may exercise all the powers of the Company to purchase and maintain at the expense of the Company insurance for or for the benefit of any person who is or was:

156.1.1 a director, officer or employee of the Company or of any body (whether incorporated or not) which is or was a subsidiary undertaking of the Company or in which the Company or a subsidiary undertaking of the Company has or had any interest (whether direct or indirect) or which is or was in any way allied to or associated with the Company or a subsidiary undertaking; or

156.1.2 a trustee of (or a director of a trustee of) any pension fund or any employees' share scheme in which any employees of the Company or any other body referred to in paragraph 156.1.1 of this Article are or have been interested, against any liability including without limitation insurance against any liability incurred by any such person in respect of any act or omission in the actual or purported execution or discharge of his duties or in the actual or purported exercise of his powers and

discretions or otherwise in relation to or in connection with his duties, powers or offices in relation to the relevant body, fund or scheme.
